Whiteley Hall is a stately side hall, double parlor frame dwelling typical of those built during the agricultural revival of the mid-nineteenth century in St. Mary's County. The chain of title for this structure shows that it was not known as "Whiteley Hall" until the twentieth century. Prior to that time, this parcel consisted of two separate tracts known as "Price's Rest" and "Truman's Lodge."

Whiteley Hall is a three bay structure with both a plain exterior and modest interior woodwork. While the interior has been somewhat reworked, the plain exterior fabric of this structure is very well-preserved. Additions to the east and west elevations of the house are sympathetic in both form and material to the main block of the structure. The architectural integrity of this dwelling makes Whiteley Hall a significant historic site in St. Mary's County.

Whiteley Hall is located at the end of an unpaved road off of the Newmarket-Turner Road (Route 6) near Huntersville. This two-story frame structure faces south with its principal gable oriented on an east/west axis.

Built in the mid-nineteenth century, Whiteley Hall is sheathed with weatherboard siding and supported by a minimal foundation consisting of cinderblock and ironstone piers. There is a partial basement under the main block of the house. From the basement, hewn logs are visible, some of which have been mortise and tenoned into place. The roof was originally sheathed with cedar shake shingles and is now covered with asphalt shingles.

The south (main) elevation of the side hall-parlor plan main block consists of three bays. The eastern most bay of the first floor is pierced by a four-panel door with a five-light transom window and three-light sidelights. This entrance door is sheltered by a Colonial Revival gable roof portico. This first floor is lit by two six-over-six sash windows with louvered shutters, and the second floor is lit by three shuttered six-over-six sash windows. This main block is finished with corner boards and a boxed cornice with a cavetto molding. To the west of the main block is a gable roof, one-story addition dating to the early twentieth century. A screened porch with a cement pad floor and square post supports stretches across the first floor of this addition. A one story addition built in the 1950s is attached to the eastern end of the main block. This addition is supported by a full cinderblock foundation and lit by two six-over-six sash windows with louvered shutters. Both additions are finished with a boxed cornice.

The west elevation of the main block is pierced by a modern door on the first floor which provides access to the screened porch addition. Two exterior common bond brick chimneys with corbeled caps stand against the west side of this main block. The single story addition is sheathed with weatherboards and lit by a pair of six-over-six sash windows. A shed roof addition, supported by a cinderblock foundation, projects to the north from this one-story wing. This addition is enclosed with screening and weatherboards.

The north elevation of the main block is pierced by a four-panel entrance door with a three-light transom. This door is sheltered by a gable roof portico with square post supports. To the east of this bay are two six-over-six sash windows with louvered shutters. The second floor is lit by three six-over-six sash windows with louvered shutters. The western single-story addition is pierced by a four-panel entrance door and one six-over-six sash window. The eastern addition is lit by one standard size six-over-six sash window with louvered shutters and one smaller version of the same.

Whiteley Hall is a stately side hall, double parlor frame dwelling typical of those built during the agricultural revival of the mid-nineteenth century in St. Mary's County. Like Loretam (SM-78), this three bay structure has a plain exterior and modest interior woodwork. While the interior has been somewhat reworked, the plain exterior fabric of this structure is very well-preserved. Additions to the east and west elevations of the house are sympathetic in both form and material to the main block of the structure. The architectural integrity of this dwelling makes Whiteley Hall a significant historic site in St. Mary's County.

The chain of title for this structure shows that it was not known as "Whiteley Hall" until the twentieth century. Prior to that time, this parcel consisted of two separate tracts known as "Price's Rest," and "Truman's Lodge." The St. Mary's County Land Records provide deeds for the property back to 1841. Tax records at the Maryland Hall of Records show that this property was owned by Isaac Smoot and his heirs between 1798 and 1826. This suggests that Philemon Keech, possessed of the property in 1826, was an heir of Isaac Smoot.

The 1798 Federal Direct Tax lists Isaac Smoot as the owner of "a dwelling house 28 feet by 20 feet, 2 windows 3 feet by 2 feet, 4 ditto 1 1/2 feet square; kitchen 16 feet by 12 feet; meat house 12 feet square; Barn 40 feet by 16 feet; cornhouse 12 feet square, all one story in good repair in the Forrest." It is unclear where this eighteenth century structure was located on the 196 acre tract, but it is of interest to note this eighteenth century precursor to Whiteley Hall.

7.1 Description

The east elevation of the main block is blind and marked with a central, exterior brick chimney. The east side of the one-story addition which obscures the first floor of the main block is lit by two six-over-six sash windows with louvered shutters. The eave of this gable roof addition is lit by one shuttered six-pane window.

The interior of this double pile, side hall-parlor plan house has been reworked and most of its original woodwork and plaster work replaced. Some four-panel doors and a plain post and lintel mantel survive. The original open stringer stair, with its turned newell post, square balusters, and molded hand rail, also survives.

Original outbuildings on the property which are remembered by the current owners include a corn crib, barn, and well house. The only outbuilding still standing is a one-story garage sheathed in weatherboard siding. The garage roof originally consisted of wood shingles which have been covered over with tin. The floor of the garage is a new cement pad.

The senior Philemon Keech died intestate in Charles County sometime in 1826 possessed of "Price's Rest," consisting of 56 acres, and "Truman's Lodge," consisting of 140 acres. Philemon Keech, the minor, is only one of Philemon Keech's heirs. James Keech claims that "said tracts of land can not be divided advantageously to any of the heirs...said tracts have been rented out and are greatly out of repair and that their value is constantly depreciating." Consequently, the judgement is passed that the tracts be sold and the money divided between the heirs.


