This long, one-story frame building served as headquarters for the Sacred Heart Beneficial Society, which was founded by Negro Catholics in the early 1890's. Like the hall of the Love and Charity Society not far away, its interior is decorated with gingerbread detail, and its stage was used for musical and dramatic productions. Both clubs included Negro members from different denominations. Neither hall is presently used and both may soon be torn down.
