This attractive one and a half story frame house looks out over Little Creek, a protected inlet that empties into St. Clement's. ~~and that~~ ^{It} serves as an excellent docking place ~~for~~ ^{for} small water craft. No doubt this site was selected because of this, ^{since} ~~and~~ its owners were , like many other Negroes in the Abell community, watermen.

The house is three bays in length and one in width. Its principal facade (south) has a door centrally located, flanked with a window on either side, each opening into one of the two rooms downstairs. The entire facade is sheltered by a screened porch. Above the downstairs are smaller ones for the upstairs rooms. On the east gable end is attached a smaller one story room that served as the kitchen.

STATEMENT OF SIGNIFICANCE

This house served as the family of Lee and Mary Maddox, according to oral informant Bernice Clark Sherman. According to her, Lee did not farm at all, but depended exclusively upon the water for his living. Its design and construction is similar to the homes of the Negro watermen of the Beachville community further down the Potomac River in St. Mary's County.
