The George H. Long house is a two-story, three-bay structure now sheathed in asbestos shingle siding. On the east end of the house is a two-story porch which was added later. The house is now divided into two apartments and a one-story, gable roof addition is attached to the rear of the house. This structure's simple architectural style represents the earliest period of building in Mechanicsville.

The George H. Long house is located on the south side of Old Route 5 in Mechanicsville, Maryland. The Long house faces north with the principal gable oriented on an east/west axis.

Built around 1870, the Long house is a two-story, frame structure sheathed in asbestos shingle siding. The gable roof is covered with pressed tin shingles. An interior brick chimney pierces the roof on the north side. The foundation has been covered with cement.

The north (main) facade is pierced on the first floor by two six-over-six sash windows with narrow surrounds and a replacement entrance door. Next to this door is a second and identical door which leads to a second floor apartment. These entrance doors are sheltered by a gable roof portico. The second floor is lit by three six-over-six sash windows. On the east end of the house is a two-story screened porch supported by square posts.

The west elevation is lit on the first and second floors by two six-over-six sash windows. The attic story is lit by one four-over-four sash window and the eave is finished with a plain bargeboard.

The south elevation of the main block is lit by one small six-over-six sash window on the first floor. The remainder of this elevation consists of a one-story, gable roof addition and a one-story shed roof addition. The shed roof addition is lit by one small one-over-one sash window while the gable roof addition is lit by one small six-over-six sash window. The second floor of the south elevation is lit by three six-over-six sash windows. There is a patch in the roof of this elevation which may have been the former site of an interior brick chimney.

The east elevation of the main block is largely obscured by a two-story screened porch. The northern most bays of the first and second floors are pierced by replacement doors which provide access to the porch. To the south of the porch, the house is lit by one six-over-six sash window on both the first and second floors. A one-story addition projects to the rear of the house. This addition is lit on the west side by one six-over-six sash window. Its gable roof is pierced by a cement stove stack.

The interior was not seen.

One outbuilding stands on the property consisting of a board and batten, gable roof garage.

Prepare both a summary paragraph of significance and a general statement of history and support.

According to local tradition, the Long house may be the oldest house standing in Mechanicsville. The Long house was certainly standing by 1873 when George Burroughs devised it to Elizabeth Copsey Long, wife of farmer George H. Long. Although it has been divided into two apartments and sheathed in asbestos shingles, the basic form of the house is little changed.

In 1915 George H. Long died and the property passed to his three children. In the 1930s, a small building stood in front of the Long house next to Old Route 5 where Mr. Long's son, also named George, operated a blacksmith shop. This George Long is listed in the 1910 census as a shoemaker with his own shop as well. By the 1950s two families were living in the house, and in 1955 Paul Colonna purchased the property. Today, it is divided into apartments.

The George H. Long house is a modest structure. Unlike other village residences which line Old Route 5, it is stepped back from the road on a lot devoid of landscaping and shade trees. The Long house's simple architectural style represents the earliest period of building in Mechanicsville.


