The Thomas L. Crowder House is significant as one of the oldest structures on St. George Island. According to local tradition, this dwelling originally housed shepherders who lived here during the Jesuit ownership of the Island. Based on the size and form of the house, it is plausible that the dwelling housed tenants and that it dates to the 1850s or 1860s. However, it is difficult to substantiate a building date for the house since the roof construction is completely sheathed with modern materials and the underside of the house is not accessible.

It seems likely that in its earliest form, the house consisted of the southern section alone. The house would have had one room on the first floor and one room in the upper half story. Access to the upper half story would have been possible by means of a hole in the ceiling of the first floor room. A ladder, rather than a stair, probably provided access to the original sleeping loft. The northern ell was probably added at a later date.

The chain of title for this lot shows that Thomas L. Crowder purchased 16 1/10 acres of the Island from Ennals Roszell in 1865. While the 1865 deed does not mention a house on the property, a house is mentioned in the transfer from Crowder to James H. Moore in 1884. Paul Davis, an oysterman, purchased the house in 1902. The Davis family occupied the house until 1953.

The Thomas L. Crowder House is located at the end of an unpaved road on the east side of Thomas Road on St. George Island in St. Mary's County, Maryland. The house stands on the western shore of Island Creek. A wood pier extends from the house lot out into the Creek. One modern outbuilding stands on the property. The original entrance to the house was located on the south elevation. The south side of the house faces the mouth of Island Creek. A plat dating to the 1930s shows two spruce trees flanking this entrance. Because of the small size of the original house, a series of additions were constructed in the mid-twentieth century to create more livable space. The principal gable of the modest structure is oriented on an east/west axis.

Built around 1865, the Crowder House is a one-and-a-half story, ell-shaped frame building supported by concrete piers. The original foundation probably consisted of wood piers which deteriorated over time. The original weatherboard exterior has been sheathed with vinyl siding. The roof is covered with asphalt shingles.

The south (main) elevation has an enclosed shed roof porch that extends across the first floor. The enclosure, added in the 1960s, is pierced by a series of one-over-one sash windows. The original exterior wall of this first floor was pierced by a single entrance door. The roofline of the upper half story is broken by a cross gable pierced by one one-over-one sash window with louvered shutters.

The east elevation has an enclosed shed roof porch that extends across the first floor. Added in the 1960s, the enclosure is pierced by a series of one-over-one sash windows and one single light window. The upper half story consists of a gable end as the southern bay and the longitudinal elevation of a one-and-a-half story wing as the northern bay. The southern bay is pierced by one one-over-one sash window with louvered shutters. The roofline of the northern ell is pierced by a cross gable and lighted by a one-over-one sash window. Both windows have louvered shutters. To the north of the main block is a one-story addition, constructed in the late 1970s. The addition is pierced by two banks of three one-over-one sash windows.

The north elevation of the shed roof porch enclosure is pierced by one one-over-one sash window. The gable end of the one-story wing is pierced by three one-over-one sash windows. The flush gable end of the ell is blind. A one-story utility room, built in the late 1970s, extends to the west. The shed roof addition is pierced by a door and one one-over-one sash window.

The west elevation of the northern one-story addition is pierced by four one-

Based on the size and form of the house, it is plausible that the dwelling housed tenants and that it dates to the 1850s or 1860s. However, it is difficult to substantiate a building date for the house since the roof construction is completely sheathed with modern materials and the underside of the house is not accessible.

It seems likely that in its earliest form, the house consisted of the southern section alone. The house would have had one room on the first floor and one room in the upper half story. Access to the upper half story would have been possible by means of a hole in the ceiling of the first floor room. A ladder, rather than a stair, probably provided access to the original sleeping loft. The northern ell was probably added at a later date. The ell, of the same size and form as the southern block, may even have been a separate house that was moved to this site to enlarge the dwelling.

St. George Island was owned by the Jesuits until 1852. Throughout the 1850s and 1860s attorney Charles C. Lancaster sold off portions of the former Jesuit estate. Most of the buyers were watermen from the Eastern shore of Maryland and Virginia. A U.S. Coast and Geodetic Survey map of 1859 shows about 30 structures standing on the island by that time. Two of these buildings are located in the vicinity of the Crowder House.

7.1 Description

over-one sash windows and a three-light-over-two-panel door. The utility room addition is pierced by one one-over-one sash window with louvered shutters. Above the utility room, the roofline of the ell is broken by a cross gable lighted by a one-over-one sash window with louvered shutters. The southern gable end of the main block is pierced by one one-over-one sash window on both the first floor and the upper half story. The enclosed porch that extends to the south is pierced by an entrance door and a one-over-one sash window.

The interior of the original section of the house consists of two rooms on the first floor. A narrow, enclosed stair built in the 1960s provides access from the first floor of the ell to two bedrooms in the upper half story. Originally, access to the upper half story was provided by a retractable stair in the southwest corner of the south room. In addition to two bedrooms in the upper half story, a storage space is located at the head of the stair. A louvered door hung on a "Bommer Spring Hinge" hides the storage area from view.

One outbuilding stands on the property. Built by the current owners, the gable roof structure is sheathed with artificial siding and roofed with asphalt shingles.



Map of St. George Island as it appeared in 1859, showing structures located on the western shore of Island Creek in the vicinity of the Crowder House.




