Based on the information provided by SHA, the Katherine Stevens House does not meet the National Register Criteria for individual listing. The property consists of a frame farmhouse dating from the early 20th century and a frame tobacco barn constructed in 1950. The house is currently used as offices and is said to have undergone extensive interior alterations in the conversion to commercial use. The well maintained cross gable house is representative of a common vernacular farmhouse type in St. Mary's County and throughout the state, but is not significant enough to meet the NR Criteria C. The property is not known to be associated with any significant event or person. In addition, it is not located in any known historic district. It is located in a rapidly developing area of the County.

The Katie C. Stevens House is significant as an example of early twentieth century domestic architecture in St. Mary's County. Originally the centerpiece of a 74 acre farm, the property has been reduced to a 1.729 acre house lot as heavily trafficked Route 235 has widened and developed into a commercial strip. This well-preserved farm house and deteriorated tobacco barn appear out of place next to the series of office buildings, convenience stores, and gas stations that define this section of Route 235 .

In 1904, Katie C. Shermantine purchased 74 acres of "Part Asquithe Defense" from Julia A.O. Davis of Baltimore City. Following Katie's marriage to Elkanah Stevens, a house was erected on the property. After Mr. Stevens died, his wife took in boarders to supplement her income. Many of these boarders were schoolteachers. In 1939, Katie Stevens sold the property to Joseph N. and Alice C. Hayden.

During Mr. Hayden's ownership, two barns, a chicken house, a stable, a corn house, and a meathouse stood on the site. One of these barns, located north of the house, still stands today. During the Hayden occupation, a one-and-a-half story kitchen wing, originally attached to the north side of the house, was removed and replaced by a small, one-story utility room. The old kitchen consisted of one room on the first floor and a small enclosed stair to a loft space.

The Katie C. Stevens House is located on the east side of Route 235 near Lexington Park in St. Mary's County, Maryland. The two-story frame structure is flanked on the north by a modern office building and on the south by a one-story residence. A tobacco barn is the only outbuilding that stands on the property. The house faces south with the principal gable oriented on an east/west axis.

Built around 1905, the Katie C. Stevens House is a two-story, frame structure with a center hall, single pile plan. It is supported by a cement foundation. The exterior is sheathed with artificial siding and the roof is covered with asphalt shingles.

The south (main) elevation consists of a central, deeply molded, four-panel entrance door. The door has two-light-over-one-panel sidelights and a three-light transom. It is flanked by one large two-over-two sash window with louvered shutters on either side. A shed roof porch supported by turned posts extends across the full width of the first floor. The porch retains its wood floor and wainscoted ceiling. In the center of the porch roofline is a small cross gable sheathed with decorative shingles. The second floor is pierced by three two-over-two sash windows with louvered shutters. The roofline is broken by a central cross gable pierced by a four-light window with a triangular crown. Two interior brick chimneys pierce the roof ridgeline.

The west elevation is pierced by one two-over-two sash window with louvered shutters on both the first and second floors. The eave is pierced by a louvered vent with a triangular cap. This gable end is finished with cornice returns. A two-story wing extends to the east. The first floor is pierced by two two-over-two sash windows with louvered shutters on both the first and second floors. A one-story addition pierced by a two-light window extends to the north. This addition serves as a utility room.

The north elevation of the one-story addition is pierced by a four-panel door and a two-light window. The second story of the two-story wing is blind and finished with cornice returns.

The east elevation of the one-story addition is pierced by one two-light window. The first floor of the two-story wing is pierced by a four-light-over-three-panel door with a two-light transom. This entrance door is sheltered by a shed roof porch supported by chamfered posts. Extending to the west of the porch is a one-bay, shed roof enclosure, built for use as a bathroom, pierced by a six-over-six sash window. The second floor of this wing is pierced by one two-over-two sash window. The gable end of the main block is identical to the north gable end.

The old kitchen consisted of one room on the first floor and a small enclosed stair to a loft space.

7.1 Description

The interior consists of a center stair hall with an open string stair that has turned balusters and a turned newell post. Deeply molded mantels survive in both the north and south parlors. Four panel doors and hardwood floors exist throughout the interior. At the end of the stair hall is a doorway that opens into the dining room/kitchen area. Three bedrooms are located on the second floor.

A tobacco barn located northwest of the house is the only outbuilding that stands on the property. The barn, sheathed with vertical siding and roofed with metal, was erected in the 1940s by Joseph Neal Hayden.

Description 7.1

The Katherine Stevens House is located in a rapidly developing area of St. Mary's County in the environs of California, near the intersection of Three Notch Road (MD 235) and Chancellors Run/Maple Roads. The 1.72 acre parcel encompasses a 1950 barn and the dwelling, and is a remnant of a larger property which has been intensely developed. The property is zoned commercial and is currently for sale. The dwelling has been converted to use as lawyers' offices.

The two-story, ell shaped dwelling, built ca. 1906 is oriented to the south, as it faces Three Notch Road (MD 235). The principal elevation is three bays wide, with a cross gable centered over the entrance. The transomed and sidelit door is sheltered by an almost full width, shed-roofed, one-story porch carried on lathe turned posts on plinthes. A smaller cross gable which interrupts the slope of the porch roof, clad with circular shingles and echoing the cross gable which surmounts it, further emphasizes the entry. A pointed, two-over-two pane sash window is located in the upper cross gable, whereas the regular fenestration of the two principal floors is composed of larger two-over-two lights. The original trim has been replaced by vinyl counterparts.

The end walls (east and west elevations) of this simple I-house are characterized by a single, double hung sash at the two principal levels, and pointed two-over-two sash located near the apex of the end gables at the roof level. The structure has been clad with vinyl siding.

Two corbelled brick chimneys are located at the apex of the gable roof on either side of the entrance hall of the center-hall plan dwelling, thus the chimneys are offset toward the center of the structure.

A narrow, two-story ell projects from the center of the north, or rear, elevation of the principal block. Two bays deep, it has been extended on the north by a small one-story, gable roofed addition with a door in the north elevation, and also by a partially enclosed one-story, shed-roofed porch on the east side of the ell. A transomed door is located in the northernmost bay of the ell, surmounted by a window at the second level. The open section of the porch is supported by a lathe turned post similar to the ones on the front of the structure.

It is reported by the previous owners, the Haydens, that John Pleisse, when converting it to offices, removed the kitchen, and replaced all original plaster and some trim in a complete renovation of the interior.


The large tobacco barn located northwest of the house is the only outbuilding located on the property. It was built by the Haydens in 1950.

The Katherine Stevens House is an early twentieth century dwelling, located on 1.72 acres, which is the sole undeveloped remnant of a 74 acre parcel called "Part of Asquith's Defense." The site is surrounded by modern subdivision and strip development, and has been converted to commercial use.

It is a very typical I-house and has no outstanding architectural interest or historical associations although the fact that it is one of only a few extant early twentieth century structures in the southeast part of St. Mary's County along MD 235 in the vicinity of California and Lexington Park confers some local significance to the site. The reported heavily modification of the interior, however, and the lack of period outbuildings have undermined its integrity.
