Just after the Civil War, the Freedman's Bureau placed a priority on educating former slaves. In the late-1860s, the Freedman's Bureau erected an African-American school near the rural crossroads community of Ridge, Maryland. These facilities were soon deemed inadequate and on January 10, 1900 a new property, situated between Maryland Route 5 and Route 235, was purchased and by 1910 a new school constructed. This one room school served the local community for thirty years. In the mid-twentieth century, however, many of St. Mary's County's public schools were consolidated and regionalized and one room school houses were thus abandoned.

— Ironically enough, on January 10, 1940, the St. Mary's Board of Education sold the half acre lot of the second school to Edward and Beulah Bennett, a prominent local African-American educator and his wife. By 1944, the Bennett's demolished the old school house and constructed a modest, one-and-a-half story, frame bungalow. Today, this center passage, double-pile plan house represents a good example of a once plentiful mid-twentieth century Tidewater house-type. Recently rehabilitated by its current owners, the house maintains integrity by the retention of its floor plan and appointments. This includes a stair embellished with scroll sawn stringers and a classically-inspired turned newel.

The Edward and Beulah Bennett house is located on 49264 Bennett Drive in Ridge, Maryland. Situated on the north side of Bennett Drive, the dwelling is positioned on a .546 acre, rectangular lot that gradually slopes down to the north. This lot is bounded to the north by a woodlot, to the west by two empty parcels owned by the current owners of the Bennett house, to the south by Bennett Drive, and to the east by a modern one story dwelling. The house lot is highly organized with the Bennett house centrally located and a driveway that extends in a U-shape around the back of the house--converging to a concrete block garage. The grassy yard all around the house is well defined by various well maintained shrubs. The property also contains a well house and a modern gazebo.

The Bennett house is one-and-a-half story frame dwelling with a four room original plan and gable roof. This modest Tidewater bungalow features a concrete block foundation and exterior frame walls that are covered with asbestos shingles. At the intersection of the wall and roof is an enclosed cornice. The asphalt shingle covered roof features a dual pitch. Near the roof's peak the slope is rather steep. The pitch changes abruptly to a more gradual slope about 1/3 of the way to the eaves. A centrally located, interior, brick chimney flue and a gable dormer project from the surface of the roof.

The primary or south elevation exhibits an open porch that has been fully enclosed. This enclosure consists of a raised brick foundation and walls covered with aluminum siding. The fenestration of this enclosed porch consists of a centrally located door flanked on either side by a window. The window to the west of the door consists of a central fixed pane picture window flanked on either side by a smaller one-over-one double-hung sash. The window to the east of the door features a set of paired, one-over-one windows. Each of these windows have a pair of non-functional louvered shutters. The door itself is a solid wood door that is decorated with a window that consists of three interlocking circles. The roof on this elevation is pierced by a gable dormer that is lit by a set of paired one-over-one windows. A piece of modest scrollwork decorates the peak of the dormer's roof.

The west elevation is pierced by four bays. A one-over-one window lights the enclosed porch, a set of paired one-over-one sash light a rear enclosed porch, and two sets of paired one-over-one windows light the main body of the dwelling. The half story is lit by a single one-over-one window.

The north or rear elevation is pierced by a door and five windows. The door is located on the west side of the elevation. It features eight panels and a three light semicircular window. It is flanked closely on either side by a one-over-one window. At the center of the elevation is an exterior cinder block flue that rises just above the roof line. To the east of the flue is a one-over-one window, a sliding glazed vent for the interior bathroom, and a small one-over-one window.

The east elevation is pierced on the first floor by two, one-over-one windows as well as one set of paired one-over-one sash. The half story is lit by a one-over-one window. A louvered ventilation cover lies just above this bay.

7.1 Description

The original interior consisted of four rooms with a center stair passage through the middle and open porches on the front and rear sides. While both of the porches have been reclaimed for interior spaces the interior layout of the dwelling remains relatively intact and clear. The stair features modest scroll sawn decoration on the stringer and a classically-inspired turned newel. The two rooms to the west of the center passage presently consist of a non-communicating dining room and bedroom. Of note is the dining room that features a wide coved entrance. To the east of the passage is a communicating sitting room and kitchen. The center passage terminates on what possibly was the rear porch. This porch, however, was enclosed and improved through the addition of a bathroom and pantry/mud room. The house also maintains its original hardwood floors throughout.


