DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This early 19th century, one story, frame cottage must be one of the smallest and latest, but also most charming, examples of the hall and parlor floor plan. Although not fully restored, the house has been well stabilized with a concrete block foundation, wooden clapboarding, and a new roof.

Each room is lit by a single 6/6 window in both its south and north sides, and is heated by an interior end chimney. A beaded board partition separates the two rooms. The west room is entered through identical doors on the north and south, each topped by a four pane transom. On the east exterior end the 5:1 bond chimney back and original beaded clapboards are exposed where they were once protected by a small one story kitchen addition.

Each mantel is nicely finished with cavetto-astragal and small ogee moldings and reeded pilasters. The architraves and chair rail exhibit unusual moldings, a slight ogee with a tiny astragal, or a very small cavetto-astragal. A cupboard with glass doors is set in the northwest corner alongside the chimney. A winding boxed stair rises in the northeast corner. The door under the stair once led to the kitchen addition.

The loft is lit by two dormers on either side of the east-west roof slope. The space is divided into two rooms by a beaded board partition. The west room is heated by a fireplace with a simply framed surround. The sloping shoulders of the chimney are exposed and plastered.

An interesting barn, perhaps of the same period as the house, exists on the property.

STATEMENT OF SIGNIFICANCE

The small dwelling on Lowe's Farm is one of the significant vernacular survivors of frame buildings dating from the late 18th century or early 19th century. In form it is similar to several early buildings, but unlike most, it has survived with few changes. It probably was closely related to Sunny Side, the original central part, prior to its subsequent addition and remodeling. It retains many original features of the period, especially the interior trim.
