DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE	
<p>Piney Point is composed of two sections constructed of frame and faced with used brick from Baltimore. Since the house was moved back from the shore due to erosion, it lacks any original chimneys. The main portion of the house was typical of the area and had two windows flanking a central door with two dormers above. It is slightly asymmetrical. The kitchen wing is longer than usual for this type building, having originally the same fenestration as the main section. There are three chimneys in the usual position.</p> <p>Joists are exposed in the kitchen ceiling and they are beaded which may indicate that this portion of the dwelling pre-dates the main part.</p> <p>Other additions are built onto the north and south sides of the kitchen wing. Between the drive and yard is an old iron fence which was made in the 19th century for the church yard at Old Wye Church.</p>
