DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Like several houses in the Neck District, the Dobos House is a one and one-half story frame structure facing south. It appears to be composed of a three bay section with a two bay wing, all having the same roof line. On the larger portion of the building is a screened porch on its south facade. There are in all three dormers across its south half of the 'A' roof.

On the east side there appears to be a hyphen and addition of recent date and different proportions.
