<p>The small dwelling standing upon the MacDonald farm on Ross Neck is almost identical to the Spencer House also on the Neck, except this building has exterior chimneys. It stands on brick piers and the walls are covered with aluminum siding. There are two windows with 6/6 sash on the main portion of the house and two dormers on each side of the roof with 1/1 sash. The kitchen wing has a sliding glass door on its south facade and one window on each of the other two sides. There is also a dormer on each side of the 'A' roof.</p>
