DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This three story brick office building, on the corner of Poplar and High Streets, dates to some time around the turn of the 20th century and has changed little except on the first story where larger windows have been added, replacing the original openings. The upper two stories remain basically unchanged but are badly in need of paint, and have not been in use for several years. The cornice is supported by carved brackets and is ornamented by modillions. There are four bays on the south facade which faces Poplar Street, and three bays on the west facade facing High Street. Above the window on the upper stories are projecting flat arches supported by carved brackets. A raised beltcourse of brick marks the second and third story divisions. Between the first and second stories is a cornice supported by carved brackets.

STATEMENT OF SIGNIFICANCE

This building was originally used as a Masonic Hall and was built by J. Benjamin Brown, a local architect. It is significant as an example of turn of the century architecture and is a visual link between the late 19th century buildings on High Street and those on this corner of Poplar Street, which are some of the most architecturally distinctive commercial buildings in Cambridge. Although this building has been altered little, the maintainence of the upper stories has been badly neglected. With paint and removal of deteriorated window shades in the unused upper stories, this could be a handsome building.


