Mt.Zion ME Church stands 40ft from the east side of Rt.335 near Church Creek it faces west. The church is sided with weatherboard and rests on brick and concrete piers. It was built by C. Earl in 1889. It is now abandoned and appears to be used only as a mortuary chapel. It is located in area known as "Gum Swamp" and the church is also referred to by that name. There were a number of black farmers and field hands in this area following the Civil War but in recent years their numbers have declined to such an extent that they cannot maintain the church.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Mt. Zion ME Church stands 40ft from the east side of Rt. 335 near Church Creek; it faces west. The church is sided with weatherboard and rests on brick and concrete piers. It is gabled (east-west) and measures 30' across the front facade and is 46' in length. There is a 5' extension under the west gable with a peaked roof that forms the entrance foyer. There are three concrete steps that lead to the double 4panel oak doors. There are three colored lights above the door (rectangular arch) they are blue, red and green. There is a central window in the west gable which is composed of 17 panes of colored glass; it has an arc top. There are 2 2-over-2 colored glass rectangular windows 5' on the north side of the building and two more identical windows on the south side. The east gabled end of the building has two of these same 2-over-2 rectangular 5' colored glass windows. The cemetery is located to the south of the church. There is an old vertical-sided Sunday School on the north side of the church.

STATEMENT OF SIGNIFICANCE

Mt. Zion ME Church was built by C.Earl in 1889. It is now abandoned and appears to be used only as a mortuary chapel. It is located in an area called Gum Swamp by the natives and the church is also referred to by this name. There were a number of black farmers and field hands in this area following the Civil War but in recent years their numbers have declined to such an extent that they cannot maintain the church. The congregation of Mt.Zion ME Church has disbanded and most of them now attend John Wesley UM Church (Liners Road).


