DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Christ Church Rectory is located on the north side of Route 18 in Stevensville, immediately to the east of Christ Church. The house and lot were purchased by the vestry in 1866, when the church was still located south of town, near Broad Creek.

This frame 2 1/2 story house is three bays wide and one room deep, with a single chimney centered at the east end of the pitched gable roof. A two story frame wing extends to the rear.

The principal facade faces south, toward the road. A door with sidelights and transom is located in the west bay on the first floor, with 2 6/6 windows to the left, three 6/6 windows on the second floor and two 6/6 pitched roof dormers on the third floor. The building rests on a continuous brick foundation and is covered with fishscale shingles, plain cornerboards and box cornice, and a tin roof. A simple open entrance porch protects the front door.

A flush chimney is centered on the north gable. A door to the right of the chimney and a 6/6 window to the left on the first floor are the only openings

STATEMENT OF SIGNIFICANCE

This frame dwelling house, probably dating to the 1840's, was purchased by the Vestry of Christ Church as a rectory in 1866, and continued in that role until recent years. In form and plan it is a typical late example of the side hall, single parlor plan that gained particular favor in the first half of the 19th century. One detail of particular interest is the pineapple pattern scrollwork on the fascia of the first floor stair landing, a feature which bears comparison to the similar work at the Clayland Price Farm (QA-221), a mid-19th century house just north of Stevensville.


