DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Walter Schmidt Farm is located on the east side of Cemetery Road just north of the intersection with Higman Mill Road.

The existing brick ranch house on the Schmidt farm is constructed on the site of an early dwelling house that was demolished circa 1961. A 19th century brick meat house still stands to the south.

According to Mr. Schmidt, the early house was frame, 2 1/2 stories high and nearly square in plan. There were four rooms on the first floor, one of which served as an entrance and stair hall. Paired brick chimneys on one gable wall corbeled together in the attic and emerged from the roof as a single stack centered on the ridge.

The meat house is 16 feet square with a pitched gable roof oriented on an east-west axis. A wide (probably enlarged) door is centered on the north facade wall. Small cut-in windows are centered in the south and west walls. A second opening has been cut in at the east end of the south wall near ground level.

7.1 DESCRIPTION

The brickwork is laid in seven- to nine-course bond. The joists rest on a flat wall plate and are mitred out from the wall to support a flat false plate. The rafters rest on the false plates and are reinforced with one set of collar beams, which are half-notched, pegged, and nailed with machine nails. The interior framing is whitewashed; the floor is packed dirt.


