Hilton Grange is a handsome Victorian Italianate two story frame structure with flanking porch and sun room. The house is reputed to have been one room moved to the present location around 1850 and enlarged with another room (now the back wing). In 1857 Dr. W. J. Sudler purchased the property and added the Italianate front section, including the office (now sun room). Around 1910 Mr. & Mrs. James Merrick added the north porch, front portico and converted the porch and office into the present sun room. They too added the doric columns between the living room and hall. What had been a typical mid-19th century house had been modernized in the early 20th century with the greatest sensitivity and craftsmanship.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Hilton Grange is located on the west side of Rt. 313, the last house in the town limits of Sudlersville. It is a five bay long, two story frame Victorian Italianate farmhouse balanced on the ends with a porch on the north and a sun room on the south. To the rear of the building is a large two story wing.

The east facade of the building is five bays long with central entry. Above the entry is a fluted Doric portico with arched ceiling. The entrance has double door with arched upper panels, sidelights, and an elliptical fanlight repeating the arch of the portico ceiling. Flanking the portico are two windows with 6/6 sash and louvered blinds. On the second story are five windows beneath a heavy bracketed cornice. Two brick chimneys rise within the gables of the building at the apex of the shallow 'A' roof.

On the north end of the building is an open porch with the same fluted Doric columns as the portico. On the south is a sun room which appears to have been a small room with porch prior to being

glazed. In the center is a glazed door with semi-circular head.

On the south gable of the sun room is a bay window with panels beneath the windows and brackets around its cornice.

On the back of the building is a four bay, two story wing with a small two story bathroom tower in the north corner and a large one story addition in the south corner.

Inside, the plan consists of the popular central hall plan with flanking living room on the north and dining room on the south; opening south of the dining room is the sun room. Behind the stair hall is a den and behind the dining room is the new kitchen. Behind the den is the present utility room which was originally the kitchen.

Original trim around windows and doors has a remarkably Georgian quality, but with Victorian profiles. The open string stair has a large turned newel and square balusters. It ascends on the south side of the hall. Between the stair hall and living room most of the wall has been removed and replaced with fluted Doric columns. The mantels in both rooms are plain classical mantels with cambered arch frieze supported on plain pilasters. The molding beneath the shelf has a Greek profile. Flanking the living room fireplace are two glazed doors to the porch. Two openings to the sun room flank the dining room

fireplace.

On the west wall of the dining room is a door with transom, now to the kitchen, but originally to a porch connecting the old kitchen. The other rooms are very simply finished.


