The Nanticoke Methodist Episcopal Church is a particularly expressive example of the Gothic Revival with its well-detailed exterior. The single-story frame structure is dated to 1895 by a cornerstone, which is also inscribed with the names of the building committee; H. Jas. Messick, E. S. D. Insley, A. F. Turner, R. G. Evans, and J. R. Travers. The most dominant architectural feature is the entrance and bell tower, which rises from a central post on the west gable end. The belfry is especially noteworthy with its intricate pointed arch woodwork executed in a manner that imitates Gothic tracery. The steeply pitched pyramidal spire is covered with pattern slate as is the main roof of the church. Distinguishing the corners of the building are buttresses, which are finished with a pyramidal shaped finial. Pointed arch colored glass windows light the main body of the church, which is extended on its north side with a lateral wing featuring a large tripartite colored glass window.

The Nanticoke Methodist congregation traces its organization back to the mid nineteenth century with revival camp meetings held during the mid nineteenth century. The lot on which the 1895 church was erected was conveyed to the trustees in 1893, which included

The Nanticoke M. E. Church stands on a gentle rise of land on the east side of Nanticoke Road (MD 349) in the village of Nanticoke, Wicomico County, Maryland. The single-story frame church faces west with the gable roof oriented on an east/west axis.

Built in 1895, the frame church is supported by a raised common bond brick foundation, and it is sheathed with aluminum siding. The steeply pitched roof is covered with patterned slate. Rising against the gable front is a centered entrance and bell tower topped by a steeply pitched pyramidal spire. Attached to the north side of the main block is a slightly shorter, single story ell wing.

The west (main) elevation of the church is a symmetrical facade with the projecting entrance and bell tower dominating the wall. The outside corners of the front wall are defined by buttresses which are finished with steeply pitched pyramidal finials. The corners of the tower are buttressed as well, and the double six-panel doors are topped by a pointed arch, colored glass transom. The belfry is distinguished by pointed arch openings on each face infilled with Gothic tracery executed in wood. The spire is covered with patterned slate. Piercing the front wall to either side of the tower are narrow pointed arch colored glass windows. Fixed in the northwest corner of the brick foundation is a marble stone inscribed, "Nanticoke M. E. Church" and the date "1895." Also included on the datestone are the names of the "Building Committee, H. Jas. Messick, E. S. D. Insley, A. F. Turner, R. G. Evans, and Jr. R. Travers."

The south side of the church is defined by four pointed arch colored glass windows. Four three-pane windows pierce the foundation wall.

The east (rear) wall features a three-sided apse covered by a shed roof. Pointed arch lancet windows pierce the angled sides. A diamond-shaped colored glass window pierces the upper gable end. The corners of the rear wall feature buttresses topped with steeply pitched pyramidal finials. The top of the east gable end wall is finished with a parapet, and the peak of the roof is accented with a fleur-de-lis shaped finial.

The north side of the main block is partially covered by a single story wing, which is covered by a slate roof like the main block. A tripartite colored glass window pierces the gable end. The edge of the roof is finished with a molded bargeboard and a fleur-de-lis finial rises from the roof peak. Piercing the west slope of the slate roof is a single flue brick stove chimney. Attached to the east (rear) wall is a modern gable roofed addition.

The interior was not seen.

Standing on the north side of the church is a modern, single-story building erected in 1995 and named "The Christian Center." The three-bay by four-bay structure has a gable front, and it is sheathed with vinyl siding.



then bellfry with gothic tracery + louvres
2 colonettes at each corner - Pediment above
each side of bellfry then spire with

at main corners.

Each window (stain glass) has pediment above
a ~~semi-circular~~ gothic arch.

resembling large Gothic window.




