The Taylor-Owens house, also known as the Janie M. Gordy house, is a relatively intact example of a two-and-a-half story cross-gabled dwelling erected during the last quarter of the nineteenth century. Occupying a prominent location on the corner of Main Street and Cherry Walk Road, the center hall plan house is trimmed with modest period decoration. The decorated rafter ends are exposed, and the bargeboards feature small medallion embellishments. Quarter-round spindle decorations accent the corners of steeply pitched cross-gabled roof. The interior survives with late nineteenth century woodwork including a turned baluster stair and period mantels and doors.

Construction of this house is estimated to date to around 1880, during the tenure of Janie M. Gordy, who acquired the property through her father, James Bounds, Sr.'s will, probated in 1852. Evidently an earlier structure preceded the current house on the lot. The house and corner lot passed to Martha Collier Gordy and Estalena Bounds Gordy in 1904 through Janie Gordy's will, and three years later the Gordys sold the property to Lee P. Taylor for \$1,100. Lee P. and Ida F. Taylor occupied the house until they transferred title to Onley E. and Amy M. Owens in August 1925.

The Janie M. Gordy house, also identified as the Taylor-Owens house, stands on the northwest corner of the intersection of Main Street and Cherry Walk Road in the northern section of Quantico, Wicomico County, Maryland.

Built around 1880, this two-and-a-half story, three-bay frame dwelling is supported on a low brick foundation, and the house is sheathed with a layer of vinyl siding over plain weatherboards. The steeply pitched roof is covered with asphalt shingles. Attached to the back of the main house is a two-story service wing that creates an ell plan for the entire structure. Joining the house on the lot is a single-story outbuilding, a two-story garage, and a small cemetery with Bounds-Gordy family tombstones.

The east (main) elevation is a symmetrical three-bay elevation with a center entrance and flanking two-over-two sash windows. The partially glazed front door is topped by a two-light transom. Louvered shutters flank each window opening. The first floor is sheltered by a single-story hip roof porch supported on turned posts. Decorative corner brackets from the porch have been removed. The second floor is lighted by three evenly spaced two-over-two sash windows and the roof is marked by a center cross gable. The cross gable is sheathed with fishscale shingles and pierced by a pointed arch sash window. The eaves to the roof are extended with the decorated rafter feet exposed. Small turned medallions embellish the bargeboards. At the lower corners of the roof is a fan-shaped spindle decoration. Rising through the center of the house is a pair of corbelled cap brick chimneys.

The north and south gable ends are essentially alike with two-over-two sash windows lighting the first and second floors. The upper gable ends are marked by pointed arch attic windows surrounded by a field of fishscale shingles. The bargeboards are embellished with the same medallion decorations.

The back wall of the front block is largely covered by the two-story service wing that is extended on the south side by a shed addition. The wing is finished with many of the same features as the front block. An interior brick stack pierces the gable end.

The interior of the house has been remodeled with the introduction of sheet paneling, however, much of the original late nineteenth century woodwork remains intact. The center stairhall retains a turned baluster stair, and Victorian mantels are found in the two front rooms. A second stair, enclosed behind a four-panel door, rises in the back room.

Due to its corner location and well preserved nature, this house is classified under Category A, which includes all structures that must be retained since they are of historic significance and/or exhibit many good architectural details representative of a period of architectural development and contributing uniquely and superlatively to the character and collective value of the structures within the district.





