The old Oliver Banks' store, also known as the "Elzey and Pollitt garage and machine shop," is an interesting example of early twentieth century commercial architecture for the lower Eastern Shore. The single-story structure, built with a parapet front to disguise the low pitched gable roof, stands in comparison to the more common two-story rectangular frame store buildings that survive in the center and south end of the village. (See WI-213, Whayland Store Property and WI-230, Phillips House and Store) The pressed metal front, made to imitate rusticated concrete blocks, also points to the new types of materials common to the early twentieth century.

Dated around 1915-16, the building was erected by Jesse M. Pollitt. The deed of transfer, executed in November 1916, identifies the property as the "Elzey and Pollitt garage and machine shop." Four years later, on the first of January 1920, Jesse and Agnes Pollitt conveyed ownership of the business location with 10 acres to Herbert P. Elzey, and the deed of transfer mentions one boundary as the "new state stone road." Herbert Elzey sold half-interest in the business location to Luther E. Payne. Shortly thereafter, the two partners transferred their half interests in the property to Oliver O. Banks, who operated a grocery in the building. For the next forty years the building was known as "Oliver Banks' store."

Prepare both a summary paragraph and a general description of the resource and its various elements as it exists today.

The Pollitt-Banks' store building stands on the south side of Allen Road in the village of Allen, Wicomico County, Maryland. The squarish single-story frame structure faces northwest with the roof oriented on a northwest/southeast axis. The store building is currently used for storage.

Dating to 1915, the single-story, three-bay frame store building is supported on a low masonry foundation, and the side walls are covered with a pressed metal sheathing that imitates rusticated concrete blocks. The low pitched gable roof is covered with asphalt shingles.

The northwest (main) elevation is divided into three bays with a center entrance and flanking display windows. The centrally positioned five-bay front door is flanked by boarded over windows on each side. A plain board surround frames the door and windows. Piercing the front wall to each side of the entrance are large boarded over display windows. The pressed metal front of the main facade has a stepped "Western" style parapet that disguises the low pitched gable roof behind. Rising through the center of the roof is a brick stove chimney.

The sides of the building are partially sheathed with the pressed metal sheathing, and occasional multi-pane sash windows mark the northeast and southwest walls.

The interior was not seen.


