The William H. Sturgis house has been more commonly known by older residents of Stockton as the Leona Collins house since Collins family ownership of this village property stretched from 1890 to the mid 1960s. Identified as one of the oldest remaining dwellings, the two-story frame house dates to the late 1860s. Built initially as a two-story, three-bay side hall/parlor house, the dwelling was enlarged with a two-story, two-bay wing that followed the same roofline as the original house. The uneven south elevation and the distinct shift in the ridge line point to this shift in building periods.

William H. Sturgis, listed as a shoemaker in the 1870 U. S. Census for Worcester County, purchased this village lot in January 1868 from George Bishop. The \$100 consideration for the property would suggest the lot was not improved substantially. Five years later William H. and Jenet Sturgis sold, "...the House and Lot now occupied by us in the town of Stockton" to Kendal Hudson for \$800. The significant price difference indicates the extant house was erected during the Sturgis's ownership. Kendal Hudson is designated at this location on the 1877 Lake, Griffing, and Stevenson atlas. In September 1890 James H. Collins purchased the property from the Hudsons.

The William H. Sturgis house, more commonly known as the Leona Collins house, stands on the north side of the Pocomoke-Stockton Road (MD Route 366) in the center of Stockton, Worcester County, Maryland. The two-story five-bay frame house faces south with the gable roof oriented on an east/west axis.

Built around 1868, the five-bay dwelling was initially erected as a two-story, three-bay side hall/parlor house that was enlarged shortly afterwards with a two-story, two-bay addition to the east. The uneven nature of the roofline, and the asymmetrical fenestration point to this shift in building periods. A service wing extends to the back.

The south (main) elevation is an uneven five-bay facade with a central entrance and flanking six-over-six sash windows. The heavily molded four-panel door with its upper panels now glazed along with adjacent six-over-six sash windows are sheltered by a shed roofed chamfered post porch. The second floor is marked by an uneven series of six-over-six sash windows. Finishing the base of the roof is a boxed cornice fitted with bed and crown moldings.

The west gable end is a plain asbestos shingled wall with a small vent to the left of the interior end brick chimney stack. The chimney is finished with a corbelled cap, and the gable end is trimmed with a molded bargeboard. The east gable end follows along similar finishes.

The interior was not seen.




