Prepare both a one paragraph summary and a comprehensive description of the resource and its various elements as it exists today.

These ruins of the Civilian Conservation Corps Work Camp are reached by taking State Highway 12 south from Salisbury, then taking a right onto Nassawango Road. After continuing for a few miles this road merges into and becomes River Road. The road crosses over the Corbin Branch of the Nassawango Creek and then enters the Pocomoke River State Forest. After about 1 mile take a right onto a dirt access road that immediately leads to the Work Camp ruins.

The Work Camp ruins consist of only the poured concrete foundations of various buildings, a brick grill, and two closed wells. All the wooden upper structures of the buildings appear to have been either burned or removed. There are four small 20'x15' foundations that appear to be the barracks. These still have bolts and other hardware on them where the wooden upper structure was attached to the concrete foundations. These barracks are arranged symmetrically and all have the same dimensions. To the east of these foundations is a covered over concrete well and also an intact brick grill. Across the dirt access road, to the east, are the remains of a 33'x31' foundation that appears to be a community building, as well as a covered over concrete well.

By all appearances these were very simply constructed, utilitarian buildings.








