The single family dwelling at 11243 Grays Corner Road near the intersection of Rte 50 and Ocean Downs Road, is not considered eligible for individual listing on the National Register of Historic Places.

The dwelling is a modest-sized, 1-1/2-story frame structure with a front gable roof, built in the second quarter of this century. The facade, located in the gable end, is three bays wide with an off-central entry flanked by a pair of 2/2 windows on one side and a single 2/2 window on the other. The house extends two bays deep, also defined by 2/2 windows. The frame structure is clad with weatherborad and the roof, with exposed rafter ends, is clad with asphalt shingles. The house, illustrative of modest residential building forms from this century, lacks the architectural distinction to qualify for listing on the National Register of Historic Places.





