**DESCRIPTION OF PROPERTY AND ELIGIBILITY DETERMINATION:**

**Summary Description:**

The T. Fisher House is located on the south side of Shore Highway (MD 404), just west of Denton in Caroline County on Maryland's Eastern Shore. The house sits on a 1.2-acre parcel at the southeast corner of the highway's intersection with Thawley Road. There are no historic outbuildings on this property. The two-and-a-half-story frame dwelling currently has a gable-front-and-wing plan. Window sash are different in each section (yet consistent within sections) suggesting two different building phases. The wing section has original six-over-six sash and the gable-front section has two-over-two sash. The structure is covered with modern materials including aluminum siding, aluminum shutters, and asphalt roof shingles.

**Significance:**

The T. Fisher House does not exhibit sufficient architectural or historical significance to be recommended eligible for listing in the National Register of Historic Places under any criteria. While this property has not been dramatically altered, it does not possess significant architectural importance in either construction or detailing. The property is currently a rental unit and has modern outbuildings.






Resource Site Map







Denton Vicinity
