Defining the northeast corner of the intersection of West William Street and Park Avenue is a distinctive two-and-a-half story brick house historically known as the "Todd House." Owned by the Bethesda United Methodist Church, the center hall/double pile brick dwelling is enriched with a bracketed eave and over-sized window openings spanned by segmental arches. Attached to the west side is a single-story bay window featuring leaded, colored glass windows.

Construction of this prominent brick dwelling was accomplished in 1902 by F. C. Todd. A short notice in the November 11, 1902 issue of the *Salisbury Advertiser* announced, "Mr. and Mrs. L. E. Williams have moved into the house recently completed by Mr. F. C. Todd at the corner of Park and William streets. This is one of the most attractive new houses in town."

Now housing offices for Bethesda Church, the house retains its essential exterior integrity and contributes to the early twentieth-century character of West William Street.

The F. C. Todd house, also known as the Bethesda Church house, is located at 107 West William Street in the Newtown Historic District, Salisbury, Wicomico County, Maryland. The two-and-a-half story brick house faces south with the orientation of the modified hip roof oriented on an east/west axis.

Erected in 1902, the two-and-a-half story center hall/double-pile brick dwelling is supported on a raised brick foundation with an excavated cellar. Fifteen-course common bond walls rise on four sides to a modified hip roof sheathed with slate.

The south (main) elevation is a three-bay facade with a center entrance flanked by three-light sidelights. The doorway fills a brick opening spanned by a segmental arch of double rowlocks. The door lintel under the arch is incised with a scrolled decoration. The front door is a replacement. Flanking the entrance are double width windows filled with fifteen-over-two sash windows inserted within segmental arched openings and flanked by double width louvered shutters. The window lintel has a incised scroll decoration under the double rowlock arch. Sheltering the first floor and wrapping around to the east side is a tapered column front porch. The second floor is pierced by paired nine-over-two sash windows also filling segmental arched openings with incised header decoration and flanked by double width shutters. Stretching across the base of the roof is a wooden cornice trimmed with machine-made brackets. The slate roof is defined by a pair of large hip roofed dormers filled with paired nine-over-one sash windows. The sides of the dormers are sheathed with slate like the roof. The four sides of the roof rise to a flattened top missing its balustrade railing.

The east side is three bays across with the porch partially enclosed. A slender turned Tuscan column supports the roof on the northeast corner. Fifteen-over-two sash windows light the first floor and nine-over-two sash windows light the second. Each opening is topped by a segmental arch infilled with an incised header. The bracketed cornice finishes the base of the roof. Centered on the hip roof is a cross gable sheathed with slate and pierced by paired nine-over-one sash windows. The edge of the cross gable roof is trimmed with the same cornice brackets. Piercing the ridge of the cross gable is a interior end brick stove chimney.

The west side is similarly detailed with the addition of a single story, three-sided brick bay window defining the northwest corner bay. The bay window features leaded glass windows in the upper sash. Centered on the roof is another cross gable sheathed with slate and trimmed with a bracketed eave. The ridge of the cross gable is pierced by an interior end brick stove chimney.

The rear (north) wall follows along similar finishes, and the interior has been remodeled as a church office.




