Relocated to a new site in 1981, the R. Frank Wimbrow house formerly stood along Nanticoke Road near its intersection with Crooked Oak Lane. The two-story, tee-shaped frame house was part of a small farm complex owned by R. Frank and Beulah M. Wimbrow, who assembled a fifty-acre property during the first half of the twentieth century. Their initial purchase was recorded in December 1919, and construction of this two-story farmhouse is dated around 1920. Modest Colonial Revival woodwork, principally the large square newel post enhanced with a dentil molding, and wire nails evident in the attic framing clearly date the house during the first quarter of the twentieth century. The house was joined on the lot by a small group of early twentieth-century outbuildings. A gambrel roofed barn remains on its original site.

Wimbrow family ownership of the property continued until Beulah Mae Wimbrow's death in 1977. The farm was subdivided and developed as Centennial Village. In an effort to preserve the house, it was relocated to a new site along Woodside Drive.

The R. Frank Wimbrow house stands at 27167 Woodside Drive in the vicinity of Salisbury, Wicomico County, Maryland. In 1981, the house was moved to this location from its original site along Nanticoke Road (Map 37, Parcel C-1A). On its new site the house faces north with the principal roof oriented on an east/west axis.

Built around 1920, the two-story, tee-shaped frame house is supported on a concrete block foundation, and the exterior is clad with vinyl siding. The medium pitched gable and shed roofs are sheathed with asphalt shingles. The house is located on a generous sized lot among loblolly pines.

The north (main) elevation is an asymmetrical facade with a projecting two-story pavilion extending forward of the entrance bay, which is sheltered by a shed roofed porch. The porch roof is supported on square posts. The front door has been replaced, and paired six-over-six sash windows mark the adjacent bay. The second floor is lighted by a pair of six-over-six sash windows. Modern replacement windows have been substituted for the original sash. Each opening is flanked by vinyl shutters. The projecting pavilion is marked by a single six-over-six sash window on each floor. An octagonal vent defines the gable end, which is finished with a slightly extended eave. Piercing the center of tee-shaped house is a single flue brick stove chimney.

The west gable end is defined by single six-over-six sash window on each floor. An octagonal vent marks the gable end. The east side of the tee-shaped house is defined by six-over-six replacement sash windows. Attached to the back and west side of the rear arm of the tee-shaped main block are single story enclosed shed roofed sections.

The interior retains portions of early twentieth-century woodwork including a Colonial Revival staircase located in the living room. A square newel post is topped by a cap molding featuring a dentil row. The newel post and a series of square balusters support a molded handrail. The doors and windows are framed by Colonial Revival moldings. Several early twentieth-century six-panel doors remain in the house. Access into the attic revealed a common rafter roof of circular sawn lumber fastened by wire nails.
