Land record research on this corner lot establishes the construction of this two-and-a-half story frame house around 1908, the year after Charles D. Williams purchased the corner lot from the William B. Tilghman Company for \$225. The cross-gabled frame dwelling was built in a traditional form with a three-bay front and a single room depth. Attached to the back of the main block was a two-story, one-room plan kitchen wing, which extended farther to the north with a single-story addition.

The corner lot and house remained under Charles D. Williams ownership until his executrices, Mary C. Jenkins and Virginia E. Long, sold the property to Lee C. and Lola M. Collins, who retained title to the house between 1943 and 1959 when they sold it to Iowa Waters.

Historically identified as the Charles D. Williams house, and commonly known as the Iowa Waters house, this two-and-a-half story frame dwelling stands on the southwest corner of Fitzwater and Pearl streets with an address of 641 Fitzwater Street, Salisbury, Wicomico County, Maryland. The house faces southeast with the gable roof oriented on a northeast/southwest axis.

Dating around 1908, the two-and-a-half story, three-bay, single-pile frame dwelling is supported on an infilled brick pier foundation and the exterior is sheathed with vinyl siding. The steeply pitched cross gable roof is covered with asphalt shingles. Attached to the back of the main block is a two-story, one-room plan wing, which extends farther back with a single story section.

The southeast (main) facade is a symmetrical elevation with a center entrance and flanking window openings. The windows have been replaced, and the door is a replacement as well. The first floor openings are sheltered by a hip roofed, Tuscan columned porch. Replacement sash windows light the second floor. A single brick stove chimney protrudes through the roof, rising on the east side of the center hall. The edge of the gable roof has extended eaves with exposed rafter ends.

The northeast and southwest gable ends have single window openings on each floor, and the edge of the roof has an extended eave with an open soffit.

The northwest side of the main block is largely covered by a two-story, one-room plan rear wing, which is extended on the north side by a partially enclosed shed roofed porch. An interior end brick stove chimney, finished with a corbelled cap, rises through the gable end. Attached to the north gable end of the kitchen is a single story section lighted by four-over-four sash windows.

The interior was not seen.


