One of the distinctive architectural elements that distinguishes the town of Pittsville is the Gothic Revival belfry and broach spire that rise atop the former Grace M. P. Church, now known as the Pittsville Full Gospel Church. Erected in 1876 and consecrated four years later, the Gothic Revival frame building stands on a Main Street lot conveyed from Eliza W. Fooks, James Laws, Sally M. Laws, William R. Laws, James H. Laws, and Thomas E. Laws to the trustees of the Grace M. P. Church on July 5, 1880. The congregation remained intact until the late 1980s. In 1989, the Trustees of Grace Church combined with the pastor and district superintendent conveyed the property to the Trustees of the Pittsville Full Gospel Church.

The Grace M. P. Church or Grace United Methodist Church, now known as the Pittsville Full Gospel Church, stands at 34670 Main Street in the town of Pittsville, Wicomico County, Maryland. The church faces south with the principal gable oriented on a north/south axis.

Dated to 1876, the single-story, rectangular frame church is supported on a low brick foundation, and the exterior is sheathed with vinyl siding. The steeply pitched roof is covered with asphalt shingles. Attached to the back of the main block is an ell-plan addition.

The south (main) facade is dominated by an entrance and bell tower which is centered on the gable end facade of the main block. The entrance is incorporated in a single-story, gable-roofed vestibule that extends forward from the tower. The pointed arch entrance is filled with double doors under a colored glass transom. Piercing the second story level is a round, colored glass window. The tower is topped by a intricately carved belfry with pointed arch openings flanked by squarish columns enriched with sawn decoration. Fixed atop each pointed arch opening is a small cross gable at the base of the broach spire. The entrance and bell tower is flanked by long colored glass windows.

The west side of the church is defined by three colored glass windows, while the east side is partially covered by the ell-shaped rear wing. An interior brick stove chimney pierces the roofline.

The rear wall of the main block is largely covered by the single-story gable roofed addition, which is oriented on a perpendicular axis to the sanctuary. The addition stretches across the back of the church with a shed roof.

The interior was not seen.




