A fine example of the Mediterranean Revival style that emerged in Chevy Chase during the interwar years, the Henderson House, built c1922, faces east on Connecticut Avenue at the corner of Aspen Street. It was one of the first houses to be built along this part of Connecticut Avenue, north of earlier development that had clustered closer to Bradley Lane. Mature landscaping enhances the setting for the house at this prominent location.

The two-and-a-half story, three-bay house is constructed of brick and sheltered by a tiled hipped roof. The house retains its original 6/1 sash windows on the first and second stories. The gabled dormer has four single-pane casement windows. A distinctive glass-paneled entrance door with vertical tripartite panes is framed with paneled lights. The full width single story porch is supported by Doric columns with fluted shafts.

A detached one-story garage with a tiled pyramidal roof complements the architectural style of the house. The garage was built by 1927.<sup>1</sup>

The house remains at its original location on a lot of 14,575 square feet.

Located in Section 4, developed by the Chevy Chase Land Company, the Henderson House is highly representative of the long range vision of the Land Company, which was established in 1890. The residence was built in the 1920s, during the maturation phase of the Land Company development. The large scale Mediterranean Revival residence on its spacious lot epitomized the architectural ideals of Chevy Chase development. Greater value was placed on Connecticut Avenue residence since lot sizes were twice as large as those on side streets. This feature further promoted the Mediterranean theme buildings on Connecticut Avenue.

Lily P. Henderson purchased part of Lot 1, Block 2, from the Chevy Chase Land Company in 1921. The house was built by 1923, when the land was valued at \$2340 and improvements at \$8500.<sup>2</sup> Although frontage on Connecticut Avenue assured easy access to the trolley line, a detached garage on the property signals the transition between the streetcar and automobile eras.

The Henderson House is similar in design to the Varnell House (#35/104), and some sources suggest the two houses may have been built by different members of the Henderson family.

The house remained in Lily P. Henderson's ownership until at least 1931. By 1941, the property was owned by C. E. Carter.<sup>3</sup>
