DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a one story brick, rectangular building approximately nine bays wide and five bays in depth and built for a food chain. The front facade is buttressed by seven piers and all brickwork is in common bond. There are large pane show windows and shop garage doors on the front while the rear and sides are lighted by 2/2 pane windows with modern soldier course brick arches and wood lintels. The roof is rather flat and the foundation is not visible.
