Description:

The Melman Property is a 1½-story, 3-bay front gable cottage on the east side of Old Gunpowder Road in Beltsville vicinity, Prince George's County. Constructed circa 1930, the building has an exposed basement on the south and east sides.

The structure has a front gable, asphalt shingle roof. It is of wood frame construction with asbestos siding and it has a concrete masonry foundation. The windows are double-hung wood sash. The house has a 1-story hipped roof porch on the west, or front facade. The porch has a wood lattice skirt, wood posts and steps, a wood floor and is screened.

There is one outbuilding associated with this building. The outbuilding is a garage, with a front gable roof covered with asphalt shingles. Constructed circa 1930, it is of wood frame construction. The structure is located immediately southeast of the house.


The property is located on the east side of Old Gunpowder Road, with residential property to the north, east, and the west. There are many mature trees on the site. The ground slopes down to the east from Old Gunpowder Road. The property's setting is suburban residential.


