Description:

The Crowley Property is a 1½-story, 3-bay cottage with bungalow features on the north side of Briggs Chaney Road in the Calverton area of Prince George's County. Constructed in 1935, the cottage has a full-width front porch and shed dormers on the front and rear elevations.

The structure has an asphalt shingle, side-gable roof and an exterior brick chimney. The south, or front elevation has a shed-roof dormer; the rear elevation has a full-width shed dormer. The cottage is of wood-frame construction with brick veneer on the front elevation, vinyl siding on all other exterior wall surfaces, and it has a concrete foundation. The windows are both 1/1 double-hung aluminum and aluminum casement. Some of the double-hung windows have applied muntins. The front porch has a concrete slab floor and wood posts supporting the roof.

There is one outbuilding associated with this property, a small asphalt-shingle, gable-roof shed. Constructed circa 1950, the shed is of wood-frame construction and it has a small shed roof addition. The shed is located north of the house.


The property is located on the north side of Briggs Chaney Road, with residences to the north, east and west. The site slopes down from the road to the northeast, and there are a few large trees in the front yard. The property's setting is a suburban area, along a road which has become a major traffic route.


