Located on Old Westover Road in Westover, Maryland, the J.P. Thomas property consists of a large, two-and-a-half story frame dwelling c. 1900. The complex roof line is defined by multiple cross gables and a hip roof. The vernacular building has been substantially altered with the construction of a modern porch enclosure, foundation alterations, concrete exterior chimneys and artificial siding and roofing. The Farmers Home Administration only provided limited information and exterior photographs for the property. Paul Touart does not believe that a historic district exists in Westover. Based on this minimal information, the building does not embody distinctive characteristics of type, period or method of construction. The building does not appear to meet criteria a or b, either.




