
The DeBerry Farm Cemetery, associated with the adjacent DeBerry Farm (MHT # G-IV-A-238), relates to the continued growth and settlement of the Oakland region in the late nineteenth and early twentieth centuries. The development of summer vacation resorts and hotels in the Oakland area in the nineteenth century had helped to stimulate settlement of the area. Toward the end of this period, a writer described Oakland as a commercial town surrounded by rich farming and grazing land. Although no longer as prominent a resort in the early twentieth century, Oakland still remained an important local mercantile and community center and continued its growth during this period. Most of the visible gravestones in the DeBerry Cemetery date to the late nineteenth and early twentieth centuries. According to an inscription on the most prominent obelisk within the surrounding fence, this cemetery was remodeled in 1931.


Research has not identified any associations with the lives of persons significant to the Oakland area's past or with events that have contributed significantly to broad patterns of the area's historical development. The architecture does not represent a particularly distinctive type, period, or method of construction, nor does it represent the work of a master, possess high artistic values, or represent a significant and distinguishable entity whose components may lack individual distinction. This resource has not yet yielded and is not likely to yield significant information important in history or prehistory.



This is a largely overgrown hilltop cemetery which stands near the DeBerry farm complex and about 75 feet east-southeast of Route 219. The cemetery consists of three sections: a rectangular front area encircled by a wire fence, a smaller rectangular area beyond the first section surrounded by a concrete and steel pipe fence, and a third, less well-defined and much more overgrown rectangular area to the rear which is also enclosed with a wire fence. The entire cemetery contains nine visible stones and several more depressions, possibly indicating additional graves. Most of the legible gravestones date from the 1880s, 1890s, and early 1900s, and most are still intact and have not been toppled or vandalized.

The DeBerry Farm Cemetery, associated with the adjacent DeBerry Farm (MHT # G-IV-A-238), relates to the continued growth and settlement of the Oakland region in the late nineteenth and early twentieth centuries. Most of the visible gravestones in the cemetery date to the late 1800s and early 1900s. This is a largely overgrown hilltop cemetery which stands near the DeBerry farm complex. It is located approximately 75 feet east-southeast of Route 219. The entire cemetery, which measures roughly 30 feet wide, is rectangular in plan and consists of three sections: a rectangular front area encircled by a wire fence, a smaller rectangular area beyond the first section surrounded by a concrete and steel pipe fence, and a third, less well-defined and much more overgrown rectangular area to the rear which is also enclosed with a wire fence.

A tall white obelisk stands near the center of the front section. The obelisk is inscribed with the following: "The construction and remodeling of this cemetery has been accomplished through the efforts of Paul Gatti from Torino, Italy June 24, 1931." Several large trees dominate this area. Although only one sunken gravestone is visible here, there are four noticeable depressions suggesting the presence of additional graves.

The middle and most prominent portion of the cemetery contains seven visible stones and seven depressions within a rectangular fenced area. These stones include the following: an arch-topped tablet for John Bunyan Brant, d. 1887; an illegible tablet with chamfered edges and a double plinth base; a square-topped stone on a beveled plinth base for Mattie Kathryn Conn, 1863-1890; a scroll-topped tablet on a double plinth base for Georgena C. Sterne Savage, 1861-1893; a square tablet decorated with a heart-shaped motif and resting on a square plinth base for Viola Conn, 1886-1893; a square-topped tablet decorated at one corner with a carved floral motif and resting on a square plinth base for Cora Mae Conn Chambers, 1882-1906; and a square-topped tablet for Hannah Kight, d. 1880. The fence which surrounds this central section of the cemetery is constructed of concrete posts and sills and steel pipe rails.

The southeastermost portion of the cemetery is heavily overgrown. At least two more gravestones, both of which are illegible, and three more depressions, possibly indicating additional graves, are located in this area. A large tree shades the center of this section. Although this cemetery is heavily overgrown, most of the stones are still intact and have not been toppled or vandalized.






