Opening in 1933, Kabin-on-a-Corner is a typical roadside commercial building erected during the boom years of the automobile in Charles County. Although moved and somewhat altered, the building retains its faux log cabin appearance and pebble chimney. In addition, what appears to be the original neon sign still surmounts the roof.

The Kabin-on-a-Korner tavern in Bryan's Road was a longtime local landmark. Established as a bar and liquor store in 1933 by Samuel B. Barkley, the tavern was built in a nostalgic, rustic style common to 1920s and 1930s roadside commercial architecture.

Opening in 1933, Kabin-on-a-Corner is a typical roadside commercial building erected during the boom years of the automobile in Charles County. Although moved and somewhat altered, the building retains its faux log cabin appearance and pebble chimney. In addition, what appears to be the original neon sign still surmounts the roof.

The building stands in a level open field adjacent to a paved parking area of a large grocery store. The store now occupies the original site of the tavern. Built prior to the completion of Indian Head Highway, the building once stood at the corner of the main road from Bryans Road to Indian Head and the road from Pomonkey to Marshall Hall (present day intersection of N. Matthews Road and Marshall Hall Road).

Kabin-on-a-Korner consists of a small side-gable frame building clad in a faux-log facing. The building has wide overhanging eaves, a low pitched roof and exposed rafter tails. A massive pebble chimney rises at the building's south gable end.

The building's facade is randomly arranged with two 8/8 wood sash windows and two single-leaf door openings. While one of these is missing its door, the other contains a wood vertical board door with faux wrought decorative strap hinges. The windows and door are cased with plain square-edged wood moldings.

The north gable end of the present structure reveals that a portion of the building was removed when it was removed. The gable wall is clad in ceramic tile and an interior door. An original window opening remains in place, however. The portion removed consisted of a lower side gable wing that extended the building two additional bays (see 1936 photo in Times-Crescent, September 11, 1936). In addition, this gable wing terminated in a smaller scale pebble chimney.

The rear of the building shows exposed structure where portions of the building have been removed. A single original window opening on the rear wall remains, but has been boarded over. Another door opening that is missing its door, opens off this elevation. A 1-story flat-roofed frame addition extends off the rear, and wraps around the southwest corner. This addition is similarly clad as the main structure and features fixed 8-light wood windows set high in the wall.

The south gable end is dominated by the massive pebble chimney. The chimney is flanked by boarded-up square window openings to

either side.

Finally, the roof is clad in asphalt shingles and surmounted by a triangular shaped metal neon sign with curved edges.

The Kabin-on-a-Korner tavern in Bryan's Road was a longtime local landmark. Established as a bar and liquor store in 1933 by Samuel B. Barkley, the tavern was built in a nostalgic, rustic style common to 1920s and 1930s roadside commercial architecture.

Samuel B. Barkley acquired the property in 1897 and 1905. Opening in 1933, the Kabin-on-a-Korner quickly became a popular local business and meeting place. Its newspaper advertisement boasted: "Right Here in Your Own County, The Most Beautiful Tap-Room and Liquor Store South of New York!"¹ In 1938, the business celebrated its fifth anniversary by offering liquor specials and a free Dr. Pepper with the purchase of a 25-cent Walter Johnson autographed baseball. In addition, the advertisement for the anniversary emphasized the tavern's "All stainless steel cocktail work bar" and its motto of "cleanliness-honesty and service."² The tavern is reputed to be the first establishment in Charles County to receive a liquor license.

Although in a deteriorated state, the Kabin-on-a-Korner building retains its commercial roadside architecture character that continues to reflect the era of the boom of automobile travel and its attendant commercial development in Charles County.



MAP






Food Lion Parking


