The Killough Cottage is a representative example of the many small summer cottages erected on Cobb Island over the first half of the 20th century. In nearly original condition, the house was one of 150 cottages erected as a vacation cottages prior to 1935. The Killough Cottage displays elements of the Craftsman style and a roughly bungalow-type form. This style and form was popular for seasonal cottages due to its relative simplicity and emphasis on porches for outdoor living.

The Robert & Mazel Killough Cottage is one of many seasonal vacation cottages built on Cobb Island in the 1930s, 1940s, and 1950s. Erected in 1934, this modest Craftsman Bungalow features a compact plan, front gable roof, and modest detailing.

Located on two lots on Cobb Island, an early 20th century vacation community, the Killough Cottage stands among a group of early "cottages." It stands on a level lot that is enclosed by wire fencing.

Standing on what was originally a poured concrete pier foundation, the house consists of a 1-story frame structure with a front gable roof and an interior parged chimney. A full-width enclosed front porch extends across the front of the house. A small visor roof shelters this porch from the sun. Another enclosed porch extends across the rear elevation and has similar visors sheltering the north and south sides of the porch.

The facade (behind the enclosed porch) consists of a centered single-leaf panel-and-light wood door flanked by 6/1 wood sash windows. The north elevation is broken by three windows, two large 6/1 windows flanking a small 4/1 window. The rear wall of the main house contains a single 6/1 wood sash window and a panel-and-light wood door. Finally, the south wall holds just two 6/1 wood sash windows. All of the windows are trimmed with square-edged wood casings.

The house has been altered by the infilling of the original pier foundation with concrete block, and by the addition/extension and enclosure of the rear porch.

OUTBUILDING:

A single frame shed, approximately contemporary with the main house, stands in the northwest corner of the lot. The shed is characterized by its sloping roof, exposed rafter tails, and wood German siding. To single leaf doors open into the shed.

After European settlement of the Maryland Colony, Cobb Island became the possession of Captain James Neale, a prominent early English settler who acquired a 2,000-acre tract in Charles County in 1642. The island likely obtained its name from Neale, who was known for his trade links with Spain. Tradition states that he paid for his colonial grant with Spanish gold coins, or "Cobs," so named for their thick and rough appearance. Thus, his lands became known as "Cobb Neck" and the island at its tip, "Cobb Island."<sup>1</sup>

The island remained unsettled until the last quarter of the 19th century. In 1889, Philadelphian George Vickers, bought the island as a summer retreat. He built a spacious eclectic Victorian house on the island which still stands today. He, his wife and children, lived on the island for six months of the year.<sup>2</sup> One significant historic event took place on the island during Vickers' tenure there. The radio pioneer, Reginald A. Fessenden, a colleague of Vickers' brother-in-law, conducted an experiment there on December 23, 1900, that resulted in the first radio transmission of intelligible speech in the world.<sup>3</sup>

The island began its modern development as a summer resort after 1918, when prominent Charles County farmer and lobbyist, Robert Crain, purchased the island. Born in 1865 to an old Charles County family, Crain went on to study law, and become one of the most

influential and successful lobbyists in Maryland. He practiced law in Baltimore and ran a large farm in Charles County, which he was constantly expanding as he bought land throughout Cobb Neck. His house, Mt. Victoria, stands today atop a hill overlooking his one-time 10,000-acre estate.<sup>4</sup>

Crain planned to market Cobb Island as a vacation destination and resort community, but first had to overcome the dismal quality of the county roads that provided access to the island. Through his numerous political ties, Crain succeeded in getting state funding for the "Southern Maryland Trunk Line," now Robert Crain Memorial Highway (U.S. Route 301), that connected the southern tip of Charles County to Upper Marlboro in Prince George's County. Construction on the new concrete-paved highway was begun in 1922 and completed in 1927.<sup>5</sup>

After purchasing the island for \$17,000 in 1918, Crain formed the Cobb Island Development Company and hired a civil engineer, Edmund P. Russell, to survey the property and lay out streets and lots. The Baltimore land agents, F.B. Bannister & Company was hired to promote and sell the lots at prices ranging from \$50 to \$200. In 1923, the first buyers purchased a lot and erected the first summer cottage. At that time, the Development Company had just begun to build a bridge connecting the island to the mainland across Neale Sound.<sup>6</sup>

Early brochures for the Cobb Island community praised its natural advantages, peacefulness, and water assets. Construction of cottages slowly increased over the next few years with 87 cottages built by 1926. The contractors James A. Dyer & Thomas Shorter built many of the early cottages on the island. By 1929, 110 cottages had been erected, and by 1935 there were 150 residences on

the island.<sup>7</sup>

By the end of the 1940s, Cobb Island had been transformed from a strictly seasonal resort community to a permanent settlement with numerous year-round residents.<sup>8</sup> As visitors took up permanent residence, the houses were altered and enlarged to accommodate year-round living. Many of the early cottages were demolished or enlarged. The community today contains over 400 homes, mostly occupied by permanent residents.

Robert Killough and his wife, Mazel, purchased lots 722 and 723 on Cobb Island from the Cobb Island Development Company's successor, the Wollaston's Manor Corporation in 1934. The present cottage was erected shortly thereafter. The couple sold the lot & cottage for \$1,000 to Henry O. Woods in 1945. By this time the couple was listed as living in Prince George's County. Woods and his wife retained the property until 1998, when they sold it to Louis M. Heslen, Jr.

The current owner plans to demolish the cottages and erect a new dwelling on the site.





RESOURCE SKETCH MAP
