Erected circa 1900, the Frank P. Reynolds House displayed characteristic features of turn-of-the-20th-century rural dwellings in Charles County.¹ Although dramatically altered, the house retained its 2-story, single-pile with rear "T" design and assymetrical facade.

The Reynolds House stood on the north side of Route 6 near the town of Port Tobacco. Its 6.3-acre lot contained a rolling landscape dotted with mature trees and surrounded by woodlands on three sides. The house stood atop a hill that dropped away at the rear. The new house that was erected in March 1999 occupies a different location northeast of the original dwelling.

The dwelling featured a solid poured concrete foundation, a wood frame structure clad in weatherboard and asbestos shingles, and a side gable roof covered in standing seam sheet metal. A single brick interior flue extended beyond the ridge line and the open eaves contained exposed rafter tails.

The facade contained four openings on the first story; three windows and a door. Two of the windows held 1/1 wood sash, while the third was enlarged and filled with a modern 6/6 metal sash window. The second floor retained two original 2/2 wood sash window, with a small third window opening holding 1/1 sash. The remainder of the building was pierced by irregularly placed windows, many of which contained original 2/2 wood sash.

It appeared that construction on a 2-story infill addition at the northeast corner of the house was never completed. Constructed of frame, the addition featured a single leaf door on its east wall and a second story entrance on its north side. Reused original sash from the main house was used to light much of the addition.

OUTBUILDINGS:

Three contributing and one non-contributing secondary resources accompany the house on its 6.3 acre site. All located behind the house on a slope that descends into the woods, the historic outbuildings appeared to date to the first half of the 20th century. One, a dilapidated frame shed featured a sloping roof, post-in-ground construction and an open front bay. The second

outbuilding was a small toolshed with a front gable metal-clad roof and board-and-batten cladding. The third historic resource was a large frame side gable garage clad in German siding and with a shed addition on its west side. Finally, the one non-contributing resource was a 1-story asymmetrical-gable frame shed located some distance northwest of the original house.

The Frank P. Reynolds house was a modest, altered example of a turn-of-the-20th century rural farm dwelling in Charles County. This house was typical of many modest rural dwellings erected in Charles County following the Civil War and prior to the modern transportation improvements of the 1920s and 1930s that opened the county to the urban centers to the north.

The land upon which the Reynolds house stood was originally a part of the "Retreat" property that once belonged to the Jenifer family. Frank P. Reynolds acquired the property through inheritance from his father, Owen Reynolds in 1899. At that time, the tract consisted of 281 acres. He promptly took out a mortgage for \$1000 on the property, perhaps to erect the house. Unfortunately, Reynolds went bankrupt four years later, and the property was sold to the Shutzes. The Shutzes sold the property to Gustav Bramble in 1909, and Bramble quickly turned the property over to James T. Klugh of Apollo, Pennsylvania for \$2810.

The Klugh's were eventually forced to give up the property after defaulting on their mortgage. The land sold at public auction for \$2100 in 1917 to Thomas J. Coulby. By this time the property was reduced in size to 240 acres. Coulby retained the property for many years. In 1946, he devised 6.75 acres of the tract along with the house to Mary Coulby Straw. The Straws sold the remaining 6.3 acres to the Scroggins family in 1957, and in 1982 the present owners acquired the property.





