Description of Property and Eligibility Determination: (Use continuation sheet if necessary and attach map and photo)

The Waldorf Store and Post Office is a two-story front gable commercial structure, located on the north side of Leonardtown Road, near the historic Popes Creek Railroad intersection. Considered one of the early commercial structures built in Charles County, its significance appears to be dramatically limited due to the many alterations and modifications that have occurred throughout its time. While some elements of the original configurations remain, the majority of the building fabric has been compromised with a multitude of "mismatched" additions, providing functionally needed spaces for its varied uses. Finally, what original fabric does remain is in a very deteriorated condition. This property is not recommended for listing on the National Register of Historic Places.

Although significantly altered, the Waldorf Store and Post Office is one of a handful of surviving early commercial structures in Charles County. Located near the intersection of Leonardtown Road and the Popes Creek Railroad, the store and post office served an important role in Waldorf's development from a crossroads village to a regional commercial center. Although once such buildings could be found at virtually every crossroads, only a handful of similar buildings have survived throughout the county.

The former Waldorf Store and Post Office building was originally a typical two-story, three bay, front gable commercial structure built at the turn of the twentieth century. Despite alterations, notable features include cornice returns and a lunette window in the attic story gable wall.

The former Waldorf Store and Post Office building is a two-story front gable commercial structure built at the turn of the twentieth century. It is located on the north side of Leonardtown Road near the historic Popes Creek Railroad intersection. The building is situated in an intensely developed section of the county and is currently surrounded by late twentieth century construction. Although substantially altered notable features include cornice returns and a lunette window in the attic story gable wall.

The original front gable, three bay building has had several alterations and additions. Most notable is a circa 1930 two story three bay, side gable wing attached to the east elevation which dramatically extends the façade along Leonardtown Road. The storefront façade has also been significantly modified with the addition of brick facing covering the exterior up to the second story windows, and modified first floor fenestration. Finally, at least five additional building periods are visible from the rear or northern elevation.

The building is of frame construction with stucco covering the primary wall surfaces. Asphalt shingles cover the roof. Two shallow shed porches are present on the façade and are supported upon square wooden posts. The foundation was not visible at the time of the survey.

The first floor of the façade has been substantially altered, obscuring the original configuration. Currently it includes a central doorway flanked by a sash double-hung wood window with 6/6 lights near the west wall, and a 1-light fixed large storefront window near the east wall. The side gable wing includes two doors in the westernmost bays and a single light fixed storefront window near the east wall.

The second floor remains fairly intact with the exception of replacement 1/1 light double-hung windows in the front gable façade. The side gable wing features three original 6/6 light wood double-hung sash windows. An exterior square chimney stack is positioned in the interior of the L where the side gable wing meets the original front gable structure.

The second story eastern elevation of the main front gable building includes two 1/1 replacement windows in their original position, while the third bay is incorporated into the side gable wing. On the opposite western façade are three replacement 1/1 light windows also in their original position.

A historic postcard of the Post Office and Store dating from the early 1900's documents the building's early form. In this photograph the store consists of the main front gable building as well as several one story additions to the western and rear elevations. A first floor front gable porch supported on wooden posts appears at the façade. Also discernable is the original weatherboard wall covering. Although the eastern façade is less visible, this image seems to predate the two story side gable wing.

Although significantly altered, the Waldorf Store and Post Office is a good example of early commercial architecture in Charles County. Located near the intersection of Leonardtown Road and the Popes Creek Railroad, the store and post office served an important role in Waldorf's development from a crossroads village to a regional commercial center. Although once, such structures could be found in every crossroads community, only a handful of similar structures have survived throughout the county.

The introduction of the railroad in Charles County following the Civil War not only provided efficient inexpensive land transportation, but affected significant physical change in the landscape itself. Along with revolutionizing the way farmers brought goods to market, the railroad caused several entirely new centers of commerce to emerge.

A railroad through the County had been proposed as early as 1854, but was delayed by the Civil War. In 1867, the idea was revived, and the Baltimore and Potomac Railroad began construction of a line between Bowie, Maryland and Pope's Creek in Charles County. Later, the Pennsylvania Railroad acquired the line and proceeded to connect it to Washington, DC via Bowie. The first regular daily passenger service from Cox's Station (present day Bel Alton) to Bowie began running in January 1873.

New "railroad" towns began to spring up along the railroad's route. Initially, each town consisted of little more than a small station, several houses, and a corner store. White Plains, Waldorf, and La Plata were all formed after the construction of the railroad, and grew up around their railroad stations. Waldorf was first established in 1872 along the B & P Railroad line. Originally known as Beantown Station, for the nearby community of Beantown, the railroad village was renamed Waldorf around the time the first post office was established there in 1880.

Commercial growth in Waldorf proceeded quickly in the last decades of the 19th century. Established businesses moved to the new village to take advantage of its proximity to the railroad, while new businesses emerged. One such established business, Peter Trotter's Wheelwright shop in Bryantown, announced in 1877 that it would open a new shop at Beantown Station. Other early businesses located in Waldorf included Kerr's Store, the J.B. Ryon & Brothers Store, both general merchandise establishments, a bowling alley, and a barber shop. In addition, two hotels were erected in Waldorf during the early decades of the railroad's operation. One of these

was Trotter's Hotel. Two hotels appear on an 1885 map of Waldorf, one on either side of present day Route 5, just east of the railroad tracks.

During the early twentieth century the store was occupied by Joseph H. Howard and Russell Howard, then trading as Joseph H. Howard & Son. After Joseph Howard's death in 1931, his real estate, including joint stock and property, was sold by his son and heirs to relinquish outstanding debts. The estate was not settled until 1939 when James P. Ryon acquired the property and took over the operation of the store. Ryon ran a store there until 1946 when he sold the property to Alexius M. Edelin. Six years later Edelin sold the building to the current owner J. Horace Berry.

Although altered over the last century, existing architectural evidence and historic photographs illustrate that the Waldorf Store and Post Office shared many of the characteristics of vernacular nineteenth and early twentieth century commercial architecture in Charles County. These characteristics include a building site near a prominent intersection of road and railroad, a front gable orientation, and a one story front or wrap around porch.

These characteristics are also found at the Gallant Green Store (CH-602) which dates to the first decade of the twentieth century and is located at the intersection of the railroad tracks and Gallant Green Road. Another example includes the Nanjemoy Store and Post Office (CH-194).






