At first glance, the Thomas-Dudley Property appears to be a typical early 20th century, vernacular frame, two-story late Victorian I-house with an attached kitchen wing. Closer examination however, suggests that the kitchen wing, consisting of a 1 ½ story single bay, one room plan, constitutes the earlier of the two structures and was built during the middle of the 19th century. Standing near and adjacent to Patuxent City House(CH-122), and connected by a farm road network, the original structure was likely once a dependency of the main house although it has since been subdivided as a separate parcel. Simply finished and including an enclosed corner stair, the c. 1900 addition was likely the home of a tenant family or farm manager.

The Thomas-Dudley Property stands in the 19th century village of Patuxent City which once boasted a store, blacksmith shop, and a number of dwellings located on small lots lining the main road. The town developed during the early 19th century as one of the several trade centers that grew up at crossroads across the county. Today, only a handful of original buildings remain in Patuxent City. These include the nearby Patuxent City House (CH-122), Old Fields Chapel (CH-112), and the Herbert House (CH-119).

Standing within the 19th century village of Patuxent City, at first glance, the Thomas-Dudley Property appears to be a typical early 20th century vernacular two-story late-Victorian I-house with an attached kitchen wing. Closer examination however, suggests that the kitchen wing, consisting of a 1-1/2 story single bay, one room plan, constitutes the original structure which was probably built during the middle of the 19th century. The house stands on the northeast corner of Prince Frederick and Brandywine Road, and faces south. A drive, deeply cut from the adjacent banks, provides access to the building from Brandywine Road. Standing near and adjacent to Patuxent City House(CH-122), and connected by a farm road network, this dwelling was likely once a dependency of the main house although it has since been subdivided as a separate parcel.

The Thomas-Dudley Property currently consists of a two story, three bay frame main block with a side gable orientation, attached to a 1-1/2 story side gable kitchen dependency. The foundation is a combination of rubble under the earlier wing, which is also found nearby at the Patuxent City House (CH-122).

The main block is covered with failing asphalt shingle roof and is clad in composition siding over the earlier novelty siding. Two interior brick chimney flues pierce the roof. A full width hipped-roof porch is supported on four turned wooden posts. The front elevation includes a centered 5-panel door flanked by a 6/6 window on either side. The second story includes three evenly spaced 6/6 windows. Moving clockwise, the west elevation is without fenestration. The rear, north elevation of the main block includes two evenly spaced second story windows above two on the first floor. A 6-panel door is also found on the first floor near the east wall. All windows in this addition are 6/6.

The kitchen wing is also currently covered in asphalt shingles and asbestos shingle siding. It has a steeply pitched roof, in contrast to the shallow slant of the main block. The front elevation includes an approximately centered door beside a window opening to the west. The rear elevation has a centered first floor window. The side, or west elevation includes two narrow 2/2 windows slightly offset from center. The strongest indication of the building's early history is found in the interior of the original kitchen wing. The first floor reveals an enclosed corner stair in the southeast corner. The stair door has a box lock and the door trim is beaded. The upstairs is an open plastered loft. Cut nails are found in the framing of the stair and the upstairs wall. While the c. 1900 addition had two interior brick chimneys, no evidence was found of an earlier chimney for the c. 1850 structure.

The c. 1900 main block, attached to the west wall of the original structure, has an open two-room plan. The center doorway opens onto the largest of the two rooms which includes an enclosed corner stair in the northwest corner. A door on the northeast corner connects to the kitchen wing. To the immediate left of the entranceway is a door that provides access to a second room to the west. Wallboard covers the interior finishes throughout, along with crude square-edged window and door surrounds capped with square corner molding. The second story of the Victorian addition is divided into two rooms, mirroring those found on the first floor.

The Thomas-Dudley Property stands near the 19th century village of Patuxent City and Old Fields Church on the Hughesville-Benedict Road (now Route 231). Although one would not recognize it today, during the 19th century Patuxent City once boasted a store, blacksmith shop, and a number of dwellings located on small lots lining the main road. The town developed during the early 19th century as one of the several trade centers that grew up at crossroads across the county. Today, only a handful of original buildings remain in Patuxent City. These include the nearby Patuxent City House (CH-122), Old Fields Chapel (CH-112), the Herbert House (CH-119), and the Benedict Road House.

Although the complicated history the Thomas/Dudley Property is currently unclear, it is apparent that the land was owned by the Morton and Smoot families during the first half of the 19th century. In 1860, likely when the improvements were constructed, the property was acquired by James T. Thomas, a prominent merchant. By 1863, Thomas was in debt and was directed by the court to sell his real estate in order to satisfy his creditors. By the turn of the 20th century the property was in the possession of Jeremiah Dudley, also an established merchant. After his death in 1902, Dudley's extensive land holdings, totaling almost 900 acres throughout the county, were divided among his heirs. The settlement of the estate continued until 1911, at which time the property was divided by a special commission of the court. The Thomas Farm was included in the widow's dower as well as several adjoining lots in Patuxent City. In 1927, Dudley's heirs in possession of the dower lands sold the property including 143 acres, excluding the Patuxent City lots to the east, to Charles Loughran.

While the use of the original one room structure is unknown, it was probably originally associated with the Patuxent City House CH-122. The c. 1900 wing, simply finished and including an enclosed corner stair was probably the home of a tenant family or farm manager.


