Ever since the mid-nineteenth century, Colton's Point has been a waterfront destination for city dwellers and countians alike. Prominently situated at the tip of the seventh district peninsula, the point displays excellent views of the Potomac River and St. Clement's Island. Exceptionally isolated from the rest of the county, however, the residents of the area needed a commercial establishment to provide for their eclectic needs. Ever since 1936, the Colton's Point General Store, Post Office, and Bar has provided neighborhood consumers with goods ranging from food and produce, to liquor, to fishing tackle. Oral narratives and documentary history would be particularly useful here in reconstructing day-to-day life in this relatively isolated outpost of the county.

The Colton's Point General Store, Post Office, and Bar is located at the northeast corner of Bay View Road and Colton's Point Road in a waterside community called Colton's Point. Oriented on a southwest/northeast axis, the commercial building is situated on a 31,250 square foot lot that is relatively flat and low lying. The property is bounded by residential lots to the northeast and northwest and roads to the southeast and southwest.

Erected in 1936, the Colton's Point General Store, Post Office, and Bar is a brick and frame building that has been extensively modified since its initial construction. The overall massing of the building is marked by two gable roof buildings ringed by a series of additions. These shed roof additions, for the most part feature exposed rafter tails. Most of the windows are six-over-six, double-hung sash windows. The post office is entered via a door on the southwest side, while the bar is entered via a door on the southeast side. Much of the building seems to be propped up on brick or concrete piers. Brick laid in an all stretcher bond covers much of the western side of the building while horizontal weatherboard sheaths much of the eastern side. The roof is covered with asphalt shingles and flattened metal.

An elevation by elevation description was not undertaken.


