Justification for decision: (Use continuation sheet if necessary and attach map)  
 The NIKE missile site at Lauderick Creek Military Reservation is located at the Aberdeen Proving Ground, Harford County. The missile site is significant for its association with military technology and U.S. defense operations of the Cold War. The Lauderick Creek NIKE site was built to accommodate the NIKE-Ajax missile, one of seven missile launch sites to protect the Washington-Baltimore area. The Army constructed the majority of the Lauderick facility in 1955-1956. The missile launch site was then quickly modified in 1958-59 to accommodate the new technologically-advanced missile, the NIKE-Hercules. Larger than the average launch facility, the Lauderick Creek facility consists of six magazines which supported 12 missiles of each type. This site retains the essential components of a NIKE facility such as the magazines and launch pads, administration and housing, and radar and control area. The integrity of the missile site is high as it retains its historic design illustrating both types of NIKE missiles launches and magazines, the setting includes portions of the original earth berms, materials represent typical military construction. NIKE sites depict a linear layout with the launch pads at one end, the administration and housing at least a half mile away, completed with the radar/control area. Lauderick Creek easily depicts this configuration and reinforces the feeling and association of the Cold War. Although under 50 years of age, the Cold War is a significant period in U.S. history.


