Description of Property and Eligibility Determination: *(Use continuation sheet if necessary and attach map and photo)*

Originally built as an elementary school by the Washington County School Commission in 1924. Huyette Public School # 7 was used until 1961 when it was closed. The one-story school has four rooms with a central hall in an H-plan. There is a later 1960's addition in the rear of the building. The two symmetrical front facing gable ends have simple pediments and colonial revival details. The front entrance porch has paired columns supporting a central pediment. On the façade side, the windows are six over six configuration flanked by two over two sidelights. The six over six windows along the side are grouped together and is typical fenestration for schools.

Constructed of brick in a common bond, the building has a rumble rough-cut irregular course stone foundation. The roof throughout Washington County has asphalt shingles. The date of construction of the original school is not known but it was probably built prior to 1912.

Although the entrance door and some of the windows have been altered and replaced, the school still retains enough integrity to convey its significance as an example of an early twentieth century rural built in the Colonial Revival Style. It is eligible for the National Register of Historic Places under Criteria A and C for its association with education in Washington County and the Revival Period of National Pike.

The Huyette School is located on the north side of the National Pike near the intersection of US 40 and MD63 in the Huyette community of Washington County. The one-story brick school was built in 1924 in the Colonial Revival Style. It has four main rooms with a central hall in an H-plan. A playground is located behind the building.

Detailed description

The school faces south onto the National Road. It has two symmetrical front facing gable ends with simple pediments and Colonial Revival details. The front entrance porch has paired columns supporting a smaller central pediment. On the façade side, the windows are six over six configuration and flanked by two over two sidelights. The six over six windows along each side of the building are grouped together and represent typical fenestration for school buildings in the early twentieth century.

Constructed of brick in a common bond, the Huyette school has a rumble, rough-cut, irregular course stone foundation. The roof has asphalt shingles and there is a later addition in the rear of the building that was added by the Mennonites to be used as an assembly hall.

Although the entrance door and some of the windows have been altered and replaced, the school still retains enough integrity of location, setting, material, feeling and association and conveys its significance as an example of an early twentieth century rural school.

Prepare a one-paragraph summary statement of significance addressing applicable criteria, followed by a narrative discussion of the history of the resource and its context. (For compliance projects, complete evaluation on a DOE Form – see manual.)

Originally built as an elementary school by the Washington County School Commission in 1924. Huyette Public School # 7 was used for grades 1-6 until 1961 when it was closed. The building stood vacant and was used for three years to store civil defense materials. In 1964, the school building was sold to the Mennonites for \$18,500 who use the building as a church school. Three different Mennonite congregations located in Washington County support the school.

The Huyette School appears to possess sufficient integrity to be eligible for the National Register of Historic Places under Criteria C as an example of a Colonial Revival style school built in the early twentieth century. The school is also associated with the Revival Period of the National Road and is eligible under Criteria A as a contributing resource. Research does not indicate that the school was associated with personages of historical importance on local, state or national level.







Mason Dixon Quadrangle






