Bridge No. 2050 carries MD 176 over Piney Creek in Anne Arundel County. The bridge was not included in the Historic Bridge Inventory. The bridge does not appear eligible for listing on the National Register of Historic Places.

Bridge No. 2050 is a single-span, four-lane, concrete encased and exposed steel beam structure. It was built around 1900, but was significantly modified in 1949. At that time, it was widened by 15 feet on each side with steel beams and the original parapets and wingwalls were removed. The bridge retains little of its original structure or materials and lacks the architectural integrity to qualify it for listing on the National Register of Historic Places under Criterion C. The property is not known to have any associations with persons or events significant to our past and thus does not qualify under Criterion A or B.


