DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The two story brick, flat-roofed, box-like structure has a boxed cornice with projecting eaves and a plain frieze. The second story windows are square with wide, plain trim. Above the first story window construction is another, plain boxed cornice, slightly more intricate in design than the roof cornice. The windows are rectangular and separated by the entrance. Over each window is a three-sash blind transom with mullion. The sides of the structure are covered with asbestos tile.


