IT IS HEREBY ORDERED, this 3rd day of November, ²⁰⁰⁹ that Retention Schedule NO. 2330 governing the minimum periods of retention and destruction for Criminal Cases be adopted with the following exception: all criminal cases initiated by indictment or information in which there is a disposition other than Not Guilty, STET or Nolle Prosequi be retained permanently and transferred periodically to the State Archives
