- annual and other official department and agency reports;
- transactional materials, such as agendas and meeting minutes; administrative materials, such as strategic and planning documents;
- compiled data, data analysis, and other statistical information;
- current information for public dissemination, such as newsletters, press releases, announcements, and guidelines;
- directories; office listings, and other contact information; and
- ephemera such as brochures.
