#### **Collection Process**

Davis reported that the final edits are being made to the website for the collection process. It will be a 2-step process. The first step will collect the name of the individual and the kind of information that they want to donate. A form will then be sent to the individual to complete step 2 – sending in the information. If it can be placed online the item will be available to the public (everything will not immediately go on the web without vetting – and some things may not be able to go online). Individuals may also make appointments to drop off items at the archives

## **Working with Coalitions**

- Klugh reviewed commissioner assignments to county coalitions. Asked that commissioners take a proactive approach in participating with coalitions and coordinating research efforts
- Research Committee members on coalitions: Baker & Klugh (Howard and Montgomery), Stevenson (Somerset), Barnes (Baltimore, Harford, Cecil), Armenti (Carroll and Frederick), Davidson (Alleghany, Southern Maryland Calvert, St. Mary's), Chavis (Lower Eastern Shore Wicomico and Worcester), Barrett (Prince George's)
- (Will also need to connect with commissioners assigned to Anne Arundel and Upper Eastern Shore)

- Connect with local coalitions

#### **Oral History interviews**

- Chavis suggested that we begin the process of conducting virtual oral history interviews as soon as mid-July. The priority is to conduct interviews with descendants and relatives of victims, and local historians.

- Klugh stated that coalitions can be helpful in identifying potential interviewees.
- Chavis suggested using the Tulsa OK Commission model
- Davis will upload the document about Tulsa to the Research Committee Google drive and will add the link to our "Resources" page on the website. (we should all review the document)

- Necessary to identify specific holdings/items for digitization. Commissioners assigned to specific regions/lynching cases where repositories are located can take the lead in communicating with individuals representing those entities

# Dr. Denise Meringolo - Director of Public history at UMBC

- Meringolo discussed a potential opportunity to involve fall 2020 public history graduate students in assisting the research efforts of the commission. The specific class is always organized around a real-world issue. This could also lead to students potentially staying engaged with the work beyond the semester. Preference would be for students to focus on individuals/events relating to Baltimore County or Baltimore City based work.
- \*Action Item\* Discuss how UMBC Public History students can assist the work of the commission

## Potential assistance in researching federal records

- Fakunle – read email from individual inquiring about volunteer opportunities with the commission. The individual has experience with the Federal Judiciary and has a research and data analysis background. The skillset of this individual can support the commission's research efforts.

## Dr. Matthew McKnight - Chief Archaeologist - Maryland Historical Trust (MHT)

- McKnight discussed the use of Ground Penetrating Radar (GPR) and its potential relevance for identifying suspected burial sites of lynching victims (ex. George Peck-Montgomery County) in cases where oral history, newspaper accounts, or other data provide an approximate location of burial). GPR can detect a prior disturbance but cannot positively identify a specific individual.
- Klugh commented that it will be important to make sure that we have a record of the burial sites for all of the lynching victims
- Haley asked about potential fees for engaging MHT GPR services
- McKnight stated that this kind of work would be considered "in service to the state" and would not necessitate funding unless there was considerable travel expense associated with accessing the site
- Can contact MHT MDLTRC member Elizabeth Hughes, or McKnight directly.
- Also discussed "Medusa" (Maryland's Cultural Resource Information System), the repository for the Maryland Inventory of Historic Properties (architectural and archaeological sites)
