## 4. Committee Reports

• Commissioner Millen said that the Logistics Committee will be drafting a lessons learned recommendation for the appendix of the final report for future commissions.

# 5. New Business Discussion and Recommendations for Final Report

- Commissioner Creary presented a detailed spreadsheet of recommendations that includes the type of reform, specific recommendations, legal justification, supporting testimony, and implementation notes.
  - The commissioners discussed the importance of historical grounding, an evidence-based approach, and specificity versus generality.
  - o September 12<sup>th</sup> at 12 PM EST Final review/comments
  - o September 15<sup>th</sup> at 11:30 AM EST Final vote on recommendations.
- Memo from Counselor Stephanie Franklin sparked a discussion.

- o It advocated for reparations explicitly for descendants of U.S. chattel slavery and warned against using broad terms that could dilute focus.
- Counterpoints raised concerns about political feasibility and community division, the importance of inclusive language while maintaining historical accuracy, and suggestions to focus on experiential lineage and community impact rather than race alone.
- Ideas for graphics for the final report should be submitted via email.
