During that discussion, Chair Fakunle asked the Public Hearings subcommittee to propose tentative hearing dates by the end of the year.

Commissioners proposed the following recommendations for the Research Subcommittee:

- Connect with local groups who are already doing this work
- Should look at media and community environment
- Response/Engagement of public and elected officials
- Important to connect the past to the present

Commissioners also raised the following questions:

- Can we access grand jury testimony from those grand jury panels related to crimes charged against individuals for lynchings?
- How should we treat the lynchings of non-blacks and those committed by blacks?

Commissioners proposed the following recommendations for the Reconciliation Subcommittee –

- Important to carefully define reconciliation in light of the history of white and black Americans
- We must shed a light on the trauma felt by black communities
- This presents an opportunity to teach add history of lynching to the State's educational curriculum (Commissioner Armenti agreed to reach out to MSDE to discuss their sending a representative to attend a future MD Lynching Commission meeting/research subcommittee meeting)

# MD Lynching Memorial Project Conference

Staff member Schwarz discussed the MD Lynching Memorial Project Conference. He invited Commission members to attend and meet with local advocates.

#### **New Business**

Commissioner Stevenson shared that Del. Pena-Mylnck is scheduled to speak to students and professors at the University of Maryland Eastern Shore on November 7, 2019 from 11:00am-12:30pm regarding the charge of this Commission.

#### **Closed Session**

At approximately 12:15 p.m., the Commission voted unanimously to move into closed session in accordance with Maryland Code, General Provisions §3-305(b)(7) to consult with legal counsel to obtain legal advice regarding compliance with the Open Meetings Act when convening subcommittees.
