and dispose of him"

N. Carroll: petition of Matilda E. Carroll 13
September 1859; order of the court 13
September 1859
Negro boy Jim, age twenty six, ran away
several times; he "has taken upon himself to
hire himself whenever he chooses so to do,
without the consent or Knowledge of your
petitioner"; his servitude would end at age
forty, but master wishes to sell servant; court
directed sale "until the time when he shall
attain the age of 40 years"
