order 27 June 1856
Free black jailed "for coming into the state"
says he is a resident of the state and has not
broken the law; court ordered Jonathan to pay
\$20 and all fees, costs and expenses, and if
he could not he was to be turned over to the
sheriff and sold at public auction to the
highest bidder "for cash, whether a resident
of his state or not for the shortest term, which
will pay the said fine"
